

Helpful hints for the big day

AS SOON AS POSSIBLE: Have you...
 —set a wedding date and time?
 —decided on the type of wedding you would like?
 —visited your minister or registry office?
 —made plans for where you would like the reception to be held?

—made arrangements to obtain a marriage licence?
 —arranged for caterer?

THREE MONTHS BEFORE: Have you...
 —chosen the bridal attendants? (Including groom's attendants)

—organized music for the reception?
 —booked a photographer?
 —planned your honeymoon and made necessary reservations? If it's abroad, don't forget your passport in your married name?
 —arranged for transportation to the church and reception? (Don't forget the

'getaway car')?
 —made up your guest list? (We suggest a separate list for each of you).

TWO MONTHS BEFORE: Have you...
 —chosen your wedding gown and gowns for attendants?
 —booked times for fittings and delivery?—made certain your husband-to-be has arranged for his wedding attire (including dress for his attendants)?
 —compiled a gift register?
 —ordered invitations from printer?
 —ordered wedding cake?
 —ordered wedding cake boxes? (Optional)
 —selected your wedding bands?
 —selected gifts for your attendants, each other and/or relatives?

ONE MONTH BEFORE: (It's getting close to the big day!) Have you...
 —posted invitations? (If not, you had better get them in the mail as soon as possible)
 —ordered flowers? Don't forget corsages for both mothers!
 —confirmed arrangements with minister?
 —set a rehearsal date?
 —completed your trousseau?
 —checked luggage requirements?
 —made appointments for you and your attendants at beauty parlour? (We suggest you make a special appointment for yourself and take along your head-dress so that there will be no problem in finding a hair style becoming to you for your wedding day.)
 —begun sending thank-you notes and keeping an up-to-date gift register?
