1) Reconstruction of Steeles Avenue from approximately 80 m west of 10th Line North to approximately 40 m west of Winston Churchill Boulevard.

2) Intersection improvements and widening at Steeles Avenue and Winston Churchill Boulevard within the following limits:

On Steeles Avenue from Winston Churchill Boulevard to approximately 280 m cast of Winston Churchill Boulevard.

on Winston Churchill Boulevard from approximately 120 m north of Steeles Avenue to approximately 80 m south of Steeles Avenue.

asphalt overlay and drainage improvements on Steeles Avenue from 20 m west of 9th Line South to 80 m west of 10th Line north.

The intersection Improvements at Steeles Avenue and Winston Churchill Boulevard will include left turn lanes on Steeles Avenue and Winston Churchill Boulevard. Curb and gutter drainage will be provided within the limits of the intersection.

The remainder of Steeles Avenue will be constructed to rural standards with roadside ditch drainage.

Plans showing the proposed work may be inspected at the Public Works Department offices, 2316 South Service Road West, Oakville, Ontario, or the North District Operations Centre, 1600 Steeles Avenue West, Milton, during normal business hours.

Lions help library out

The Georgetown Lions Club has come to the rescue of the Halton Hills Library Board, chipping in \$1,301 so the board could qualify for a \$5,000 provincial grant.

The board acknowledged the donation with thanks last week.

At stake was a ministry of citizenship and culture offer of \$5,000 to purchase materials and equipment for physically handicapped, native multilingual and residents.

librarian Chief Betsy Cornwell told the board that in order to qualify for the grant, it would have to match 25 per cent of the total. That's where the Lions came in, she said.

Cornwell has projected a \$4,800 cost for new largeprint and talking books, plus \$405 for cassette playback units to go with the talking books.

sought for sludge While regional and provincial officials scour Halton for liquid and solid waste disposal sites, four possible locations have been identified for a \$2.7 million central

sewage sludge storage container. Envirosearch Ltd., a Rockwood consulting firm, has narrowed down a field of 25 potential sites for the sludge container to four locations-three in north Oakville and one in Milton.

Since 1980, sludge sediment from several sewage treatment plants around the region has been trucked to selected farms for spreading over the fields. The sludge is beneficial to crops and the region plans to continue the practice through the end of the century.

During periods of adverse weather conditions, however, the sludge must be stored in special containers.

Envirosearch's recently-completed update on the situation is now being circulated among interested agencies for a 60-day examination period. Included in the report is an outline of each of the four sites recommended as candidates for "in-ground storage bags" made of high-density

polyethylene or concrete. A central location is required for the storage facility, which is expected to cost \$2.7 million and contain the sludge for periods up to six months.

The four candidate sites are: Lot 5, Concession 2 in Oakville, a 160-acre farm now up for sale which features a house and barn and would involve the lowest

development cost; Sikorskiego Park on Lot 4, Concession 3 in Oakville, a picnic and camping area now being sold;

Lot 27, Concession 2 in Oakville, recently acquired by the province for the construction of Highway 403, and featuring open space isolated from nearby homes;

Lot 14, Concession 5 in Milton, also owned by the province, is good quality farmland.

The Envirosearch report indicates that problems the region has experienced processing sludge at its Burlington Skyway treatment plant will likely continue. Concern is expressed over cadmium levels in the sludge which could affect the plant's ability to blend all sludges from across the region into a consistent level and acceptable




