Prayer vigil at hospitals

Campaign Life is asking fathers and their sons to keep a one hour prayer vigil outside of Halton Region hospitals that do abortions on Father's Day, Sunday, June 17.

Campaign Life recently obtained copies of abortion statistics for every hospital in Ontario covering abortions from 1980-82 from 83 Ontario hospitals. The total of the three years of abortions is 93,102.

Statistics for Halton Region show that 1,534 abortions took place in four Halton hospitals in the three years span. Georgetown Hospital performed 46 abortions, Milton Hospital 74 abortions, Oakville Trafalgar Hospital 561 abortions and Joseph Brant Hospital, Burlington, 853.

A resolution was passed calling for the Esquesing Historical Society to not only be informed but also asked to comment on road name changes.

Parkland free charged before policy passed

Levies cannot be charged retroactively was the lesson emphasized at Halton Hills council Monday night.

The discussion arose when Councillor Pam Sheldon pointed out Julius Geist had been told he must pay a fee for parkland as a condition of obtaining a land severance, two weeks before council approved the policy of charging the fee.

She emphasized the recommendation to charge the fee was made at the April 9 meeting and a week later council approved that policy, but on March 27, Halton Land Division Committee, acting on a letter from Clerk Administrator Ken Richardson, imposed the not-yet-adopted policy.

"Council makes policy and staff implements it, "stated Sheldon.

Richardson explained as administrator he took it upon himself to write to the LDC asking them to impose the charge with the condition the owner enter into an agreement with the Town, "if council didn't approve it the agreement would be null and void and the fee uncollectable." He claimed the applicants were informed at the LDC meeting.

Councillor Mike Armstrong asked why Geist did not appear before council to make his appeal. Sheldon said he was uncomfortable talking in public and preferred to do it by letter.

A letter from Solicitor Peter McWilliams was sent to the mayor.

Armstrong opposed the resolution not to charge any applicants who sought a severance before the policy was approved, contending they were informed at the LDC meeting. He said no-one had appealed the LDC decision.

Councillor Dave Whiting termed the fee "a retroactive requirement" which be could not approve. He pointed out that being informed at the LDC meeting is too late, since the applicants are already there with a lawyer whose fee would have to be paid. "Legislation should only be effective after it is officially passed."

Councillor Phil Carney questioned the legality of charging a fee before the policy was passed and said anyone in good conscience would agree. He also questioned the amount of the fee set at \$750 in the rural area, and \$1250 in the urban area. He claimed the amount was arrived at based on five per cent cash in lieu of parkland, a common clause in subdivision agreements, but seldom if ever used in single lot severances. He claimed the five per cent should be based on raw land, prior to the severance, since the price of land increases the moment severance is allowed.

Councillor Finn Poulstrup said council may have the right to do it, but said it was morally wrong to charge after the fact.

Solicitor Bert Arnold who had appeared at the LDC on behalf of another client who also had the charge imposed, explained the applicants could not appeal one condition of a severance without appealing the whole severance, thus putting their own severance in jeopardy. He said he pointed out to the LDC members the policy was not yet in

On a recorded vote, Councillors Ross Knechtel, Harry Levy, Mike Armstrong and Mayor Russ Miller opposed the motion to lift the parkland fee an any applications made before the policy was officially approved by

Housing starts drop in '84

Housing starts until the end of April were one third the number of the previous year.

This year nine house permits have been

issued, while last year 27 were sold.

In April construction started on six houses, but alterations continued to boom ahead with 30 permits issued.

The trent toward additions and alterations continues with 51 permits issued until the end of April this year, and 57 at the same tine last year.

Alterations to convert a store to O'Tooles Tavern in Georgetown are listed at \$40,000 and an addition to a commercial building, in the commercial area on Mountainview just north of Guelph Street is listed at \$60,000.

The April total of all types of permits was \$1 million only slightly less than the previous year's \$1.2 million, but the four month total of \$1.7 million this year, is more than \$2 million less than last year's \$3.8 million.

The Canadian Style Donuts shop at the corner of Mill and Main Streets has begun to be demolished to make room for a downtown parkette. Work crews rip up the roof and tear out
