Acton Sabres: sidelined by lack of manpower

Writhing in its death throes, the Acton Junior B hockey club has issued a plea for

Financially declawed, the Sabres need an infusion of financial support to start the next season. Added to financial woes is a critical shortage of manpower that, if left unsolved, will spell the doom of the club.

"We are appealing to the conscience of our supporters to come out and help get the team back on its feet," said president of the Sabres, Frank Allsop. "Without additional manpower, fresh ideas and community sup-port the team will be finished," he added.

The Sabres, who have had offers from two men to buy the team, were left holding the bag after both deals fell through.

Godwin Carachi, who had been making moves to take over the organization since last November, pulled out of the deal last month for unknown reasons and Dave Innes, the most recent potential buyer, had to withdraw his offer after a partner included in the deal withdrew.

The present executive of the Sabres, which has been involved with the team for several years, expressed their reluctance to commit themselves to another year's work running the team because they are tired and feel new people with new ideas is the only thing that will save the Sabres from extinc-

"Therefore," said Allsop, "there will be a general meeting for all persons concerned on July 5 at 7.30 p.m. at the Acton Legion. While the Sabres plight seems hopeless there is light at the end of the tunnel because of Dave Innes.

Innes, who runs a men's hockey league in Mississauga, has offered some financial support for the team and given the support of the community he is willing to extend all the help he can for the Sabres.

"I really want to see the Acton Sabres survive," said Innes, "but I can't do it alone. I really need some responsible, hard working people to help me get the Sabres back in action for the coming season."

The present executive also agreed to help out in any way they can, but stressed that they need to see a good turnout for the upcoming meeting.

Sabres saga a tale of woe teams almost ready to fold

When Frank Allsop took over the position of president of the Acton Sabres his two biggest concerns were the continuation of funior hockey in Acton and finding a major sponsor, or owner, for the leam.

In the past eight months thoses two goals. were almost realized. Then disaster struck. Last November the Sabres executive received a letter of intent from Godwin Carachi, a private businessman, to purchase the Sabres.

It was understood by the Sabres executive that Carachi was to be the major sponsor of the Sabres for the remainder of the 1983-84 season and at the end of that season he was to take over the team and run it as he wished, said Frank Allsop.

Carachi claimed last spring that he has no intention of becoming the team's sponsor but he did want to see how things were run and he did intend to buy the team at the end of this hockey season.

During the season Carachi said he spread

some of his money around paying players and investing in new equipment. Carachi also said he paid for the Sabres' Christmas \party.

Allsop maintains that Carachi didn't hold up his end of the financial bargain and as a result the Sabres are now broke.

"We believed that Mr. Carachi was going to spend some money on the Sabres in the 1983-84 season so we (the organization) spent more money than usual on sticks, tape and other related items for the team," said Allsop. "As a result the Sabres organization went through more money than they usually would leaving us without enough funds to start the 1984-85 season."

In speaking to both Carachi and the Sabres executive last Febuary everything seemed to be going well for the team and their potential owner. There hadn't been any real disputes over the contracts, which were floating between Carachi's lawyer and the Sabres' lawyer, Ss' awe Aldo Braida.

At the end of April when the Sabres had finished their season and the final contract was put forth, by Carachi, to the Sabres executive to be signed, the worst problems

Carachi's contract stipulated that none of the present Sabres' executive, nor their children, would be allowed to compete with the Sabres within a 10 mile radius. The way the contract was worded also led the executive to believe that they could have nothing to do with hockey-period-in the designated ar area.

Unhappy with the contract, both Carachi and the executive agreed to revise it through Mawyer Alo Braida and return the papers to Carachi for signing before May 31.

The contract was in Carachi's hands before May 31 but when no action had been taken on the proceedings two weeks after the May 31 deadline, the Sabres executive began to worry.

After attempts to contact Carchi failed, the Sabres were provided with another alternative. Dave Innes and Dave Switzer, who were to be named the Sabres' general manager and head coaching positions by Carachi came forward with an offer to buy the team.

Allsop called Innes and Switzer a godsend meanwhile neither could possibly run the team.

When arose the next set of problems. Switzer, who was expected to financially help the team, withdrew his offer, leaving Innes to take over the team by himself.

Innes noted that he couldn't run the team by himseld. Consequently, the second offer to buy the Sabres fell through.

into mountains as an inventory of the team's equipment revealed several missing items tallying almost \$2,000. Allsop said their were no clues to locate the missing items. Combined with the fact that it would take

At this point man-sized problems grew

almost \$13,000 to get the team started for the year both Innes and the executive were left wondering if the Sabres were doomed.

At a meeting on June 16, with most of the executive and Innes present, the two parties came up with a plan of action.

Allsop decided to call a general meeting to inform the public of the Sabres situation and hopefully draw into the arena some new members for the Sabres' executive.

Allsop said he was willing to help out with the team in a small way for the coming season but he, as well as many of the other executive felt that they had been with organization long enough. They were tired, some had health problems and others had other commitments that would keep them from running the Sabres as it should be run

with 100 percent dedication. Innes, who had only commented on his previous intentions, said he was willing to make a financial contribution to the Sabres and the biggest problem now lay with the shortage of executive.


The bottom line now is that if the Sabres can get some new blood into the executive the first major obstacle will be cleared.

Innes said he was surprised at the response from the players which indicated most of them were willing to come back for another season with the Sabres.

Innes also said he was willing to try and come up with sponsors to help pay the team's expenses and at the same time find a coach who could possibly help the Sabres become a contending team.

However, future of the Sabres lies in the hands of the public. If there isn't a positive response at the general meeting scheduled for July 5 at 7:30 p.m. at the Acton Legion, the Sabres may be finished.
