Reject two severances Hinton allowed one

A request by Herb (Bert) Hinton of Acton to sever two parcels of land fronting on Willow Street was rejected by Halton Land Division Committee this week.

The committee agreed to one severance which would combine a four unit apartment building and adjacent paved lot. Hinton wanted them split into two lots. In the staff report, it was pointed out there

would be no on-site parking for the apartment building, and stressed the paved lot is only 27 by 56 feet. Leaving no room for parking if the site was built upon. Hinton argued the Town planning staff

should be present to support their written opinion, and agrued it was the duty of the Land Division Committee to have them at the meeting. He claimed statements in the planning report were inaccurate and said the committee should not reject the application simply because the municipality objects.

Committee member Dolly Moulden asked what parking would be provided for the tenants if the two severances were allowed. Hinton said the tenants use various town

and church parking lots nearby. He said the apartment building was one of the first buildings in Acton and was a lumber mill, built by Adams for whom the town was then named.

After the committee passed the resolution allowing only one severance, Hinton indicated he would appeal to the Ontario Municipal Board and repeated his claim that the LDC has a duty to have the people who write reports present at the meeting to back them up.

"The ordinary citizen would have to do that," he concluded.

In for observation

A Provincial Court judge in Guelph has sent an Erin mother charged with the death of her baby to St. Thomas Hospital for 60 days of observation on Sept. 18.

Leslie MacPherson, 21, of 19 Dundas St., Erin was charged with first degree murder of her six-month old son, Ian, Sept. 14.

MacPherson will make another appearance in Provincial Court on November 15.

Installing new light posts causes stink downtown

What started out as a routine drilling the scene to correct the problem, but by the operation may turn into a \$7,000 headache for the Region after a Mill St. sewer line was broken a week ago Sunday.

According to John MacKay, the Region's manager of maintenance, work crews were drilling holes to install new light standards.

When one of the drilling operators struck a sanltary sewer servicing the Sit 'n' Bull Tavern, water and sewage backedup to flood parts of the building.

Work crews were immediately called to

time the mess was cleaned up, there was a \$2,000 repair bill, MacKay claimed.

Desmond Noblett, owner of the tavern, estimated there was \$5,000 damage to his property when the disrupted sewer backed

Neither Ken Anderson, the Region's solicitor, or Zulton Kovacs, the Region's insurance officer, could confirm Noblett's claim for damages.




