Know Yourself is Aim Of Group Dynamics

Tired of the same old thing. Try group dynamics. The Georgetown Y Teen Leaders participated in a four week session of group dynamics conducted by Eric Eamon.



WHAT YARDSTICK?

Eric Eamon is the executive director of the Brampton YM-YWCA. He is associated with the Georgetown Y on a consulting basis. He is especially active with the Y Teen Leaders.

Mr. Eamon felt this experience was successful. He said it could have been even better if the course was longer (10 weeks) and the group smaller (15).

He feels to communicate honestly with people we must deal with feelings. How many of us measure people by their feelings and opinions or do we use their material possessions as our yardsticks.

REACTION

The purposes of these sessions were to try to help each teenager to get to know himself.

To help him to know how others see him. In other words, does he perceive himself as others do.

This was attempted by noting how each one reacted to the others within a group and if they were able to communicate with each other.

Naturally, there were some rules to follow. The 32 teenagers were expected to carry on with no agenda and no chairman. Someone would have to start the ball rolling. One other important rule added a small obstacle. No one could say "no" or "yes" he had to say "I".

FRUSTRATING SILENCE

These sessions commenced with a very frustrating silence until someone was finally compelled to talk.

Consideration was another prime goal of this experience. Mr. Eamon encouraged the group to talk about a subject of total interest to include everyone. Also he aimed to have everyone listen. He was sensitive to the feelings and opinions of others.

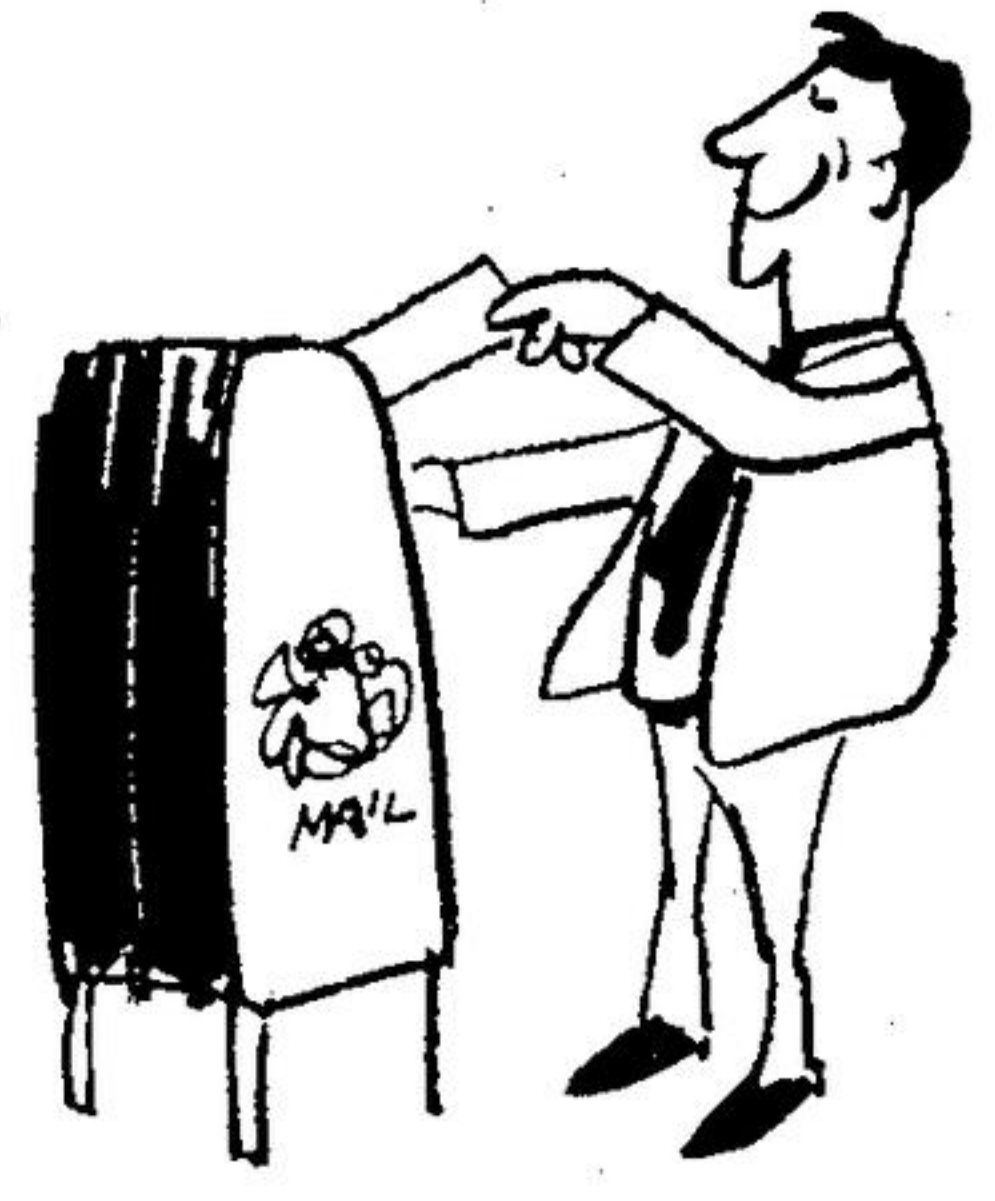
