**Extend Services, VON 61% More Visits in 1970**

Five thousand, five hundred and twenty-nine visits were made by the Oakville branch of the Victorian Order of Nurses last year, an increase of 61% over 1969, it was revealed by nurse-in-charge Mrs. Gail Beddome, at the VON annual meeting, January 20, in Lusk Hall, St. John's United Church, Oakville. Two hundred and eighty people used the services of the VON in the first full year the Oakville Branch has serviced all of Halton County except Burlington which has its own VON branch.

Guest speaker Dr. R. M. King, physician in charge of Home Care and Medical Rehabilitation, Special Health Services Branch of the Ontario Government, spoke on The Future of Home Care. He explained that Home Care had been put under the jurisdiction of the Department of Public Health in January 1970, formerly having been part of the Ontario Hospital Services Commission.

Lauding the work of the VON Dr. King stated that the future of Home Care Services depends to a large extent on the co-operation of the VON. Of the sixteen Home Care nursing programs now in operation in Ontario, 13 are operated by the VON and as far as these existing programs are concerned, Dr. King said no change is con-

templated at the present time. Explaining the aims and objects of the new department further, Dr. King said the Department believes that the Board of Health is the logical agency in the community to co-ordinate health services, and that when the Home Care program is launched at the Provincial level, the service will be covered 100% by health insurance.

Services co-ordinated under the Home Care program would include bedside nursing or visiting nurse service as provided by the VON; homemaker service to the home of the patient; physiotherapy, occupational and speech therapy in the home; drugs, dressings, Lab supplies, and special equipment for the sickroom; and transportation for the patient when needed to and from the hospital.

Most of these services already exist in the community, Dr. King pointed out, again emphasizing that the Provincial Home Care Plan is really an introduction of a co-ordination of services which already exist, under the direction of the attending physician.

To take advantage of the Home Care Plan a patient must qualify under several headings. First, he must be under medical supervision; he must have a condition capable of being treated at home; the family must be

willing to participate; and the home must be suitable for Home Care. Two very definite lines have already been drawn by the Department. A limit has been set on the length of time a patient can receive treatment under the Home Care program, since it is not a program designed for the chronically ill. The other proviso is that the patient must have a definite physical, rather than psychiatric illness.

In addition to the element of co-ordination of existing services, the Home Care program includes evaluation of the condition of the patient during such care.
