The expression, moving expenses, probably means many things to different people. Can you be specific regarding the types of moving expenses which can be deducted from income for income tax purposes?

Yes, moving expenses would generally include the cost of travelling from a former to a new residence. including meals and lodging while en route. transportation and storage costs for household effects. and the cost of up to 15 days temporary board and lodging near the former or new residence.

What about the cost of cancelling a lease, ad-vertising and legal costs, or real estate commissions. Are costs of this nature regarded as moving ex-

penses? A. Yes. Each of the items you mentioned is included in moving expenses. We should probably mention that expenses for any work done to improve the property before sale, or mortage penalty when the mortgage is paid off before maturity, or any loss incurred on a sale are not included in moving ex-

Q. I have received a scholarship from university which requires me to move to another city. understand that the amount of the scholarship over \$500 must be reported as income. Can I deduct my moving expenses to the university?

A. Yes. The amount of the scholarship over \$500 must be declared as income and you may deduct moving expenses to the extent of such income declared in your return. Moving ex-penses include travel costs. meals and lodging while en route, transportation and storage costs of your household effects, lemporary quarters, etc., for yourself and your family. Enquire at your District Taxation Office for a brochure on "Moving Expenses'

Regarding the tax of capital gains, what if property was acquired before January 1, 1972, at a cost of \$2,000 and was worth only \$1,000 on Valuation Day. If later this property was sold for \$2,500, will the capital gain in this case be \$500 or \$1,500?

A. In this example the capital gain would be \$500, the actual gain over the period of ownership, one half of which would be taxable.

In this case you would have a capital loss of \$100, the difference between the fair market value on Valuation Day and your actual selling price, onehalf of which, or \$50 would be deductible from income.
