## Figure skaters, minor hockey agree on times

After an in camera session between Pat Sheehan, facilities superintendent for the Halton Hills recreation department, representatives of the Georgetown Figure Skating Club and the Georgetown Minor Hockey Association, an agreement was finally reached concerning ice times at the Gordon Alcott Memorial Arena and the Georgetown Memorial Arena.

It was agreed that the figure skating club will use the Georgetown Memorial Arena on Sundays between the hours of 5:30 p.m. and 10:30 p.m. and the minor hockey association will use the Gordon Alcott Memorial Arena on Sundays between the hours of 7:30 p.m. and 9:00 p.m. House league hockey will be played at the Gordon Alcott Memorial Arena on Sundays from 9:30 p.m. to 11:30 p.m.

Mr. Sheehan pointed out that the alterations will affect the times allocated for public skating. However, the changes will only reduce the times for public skating by two hours for one evening only.

The decision followed a presentation last week to town council by members of the figure skating club who protested the ice times they had been allocated at the old arena on Sundays.

Ron Snow, representing the Georgetown Figure Skating Club at last Thursday's meeting of town council, noted that their main complaint in the entire issue is that they still have not received a reason for the second change in ice time schedules at the old arena.

That change, he warned, could cause the figure skating club to cancel its entire winter program.

"If we are not permitted to skate from 5 to 10 p.m., our professional staff, who were signed on the understanding that that was when they would instruct, could seek indemnity for the wages they will lose, plus for pupils' fees that could run as high as \$6,000."

"We just don't have the money."

"In the event that the pros do insist upon receiving their pound of flesh, so to speak, we will just not be able to operate this year."

Outlining the history of the ice time conflict, Mr. Snow made a point that "we are not at war with the hockey group. We just want reasons for the changes."

The figure skaters, when

they originally approached the recreation department to set up ice times, had requested Sunday afternoons at the old arena from 12 noon to 6 p.m. Doug Collison, recreation director for the town, shortly afterwards informed the club they could have 5 to 10 p.m. on Sundays.

It was on that agreement, given in early July, that the figure skating club signed its professionals.

The agreement was both verbal and written, said Mr. Snow, although the letter in which the 5 to 10 p.m. hours were set out is missing.

Councillor Dick Howitt stated, "In that light, I have to agree that there is some moral obligation on our part to accommodate the figure skating club."

When Mr. Snow contacted Joe Pentecost, president of the minor hockey support group, about a possible switch in hours Mr. Snow was told "that while he appreciated the position our club was in, he would still recommend that they not change for us."

"When we talked to Collison again," said Snow, "he told us that there was nothing that he could do. He was committed to the hockey groups."

"How can he be committed to the hockey groups and not to any other groups?" Councillor Pat McKenzie commented that "because the figure skating club must hire professionals, I would say they should have priority over the

hockey group." Aside from the Sunday hours Mr. Snow commented that the club was quite satisfied with all other ice rental arrangements with the town.

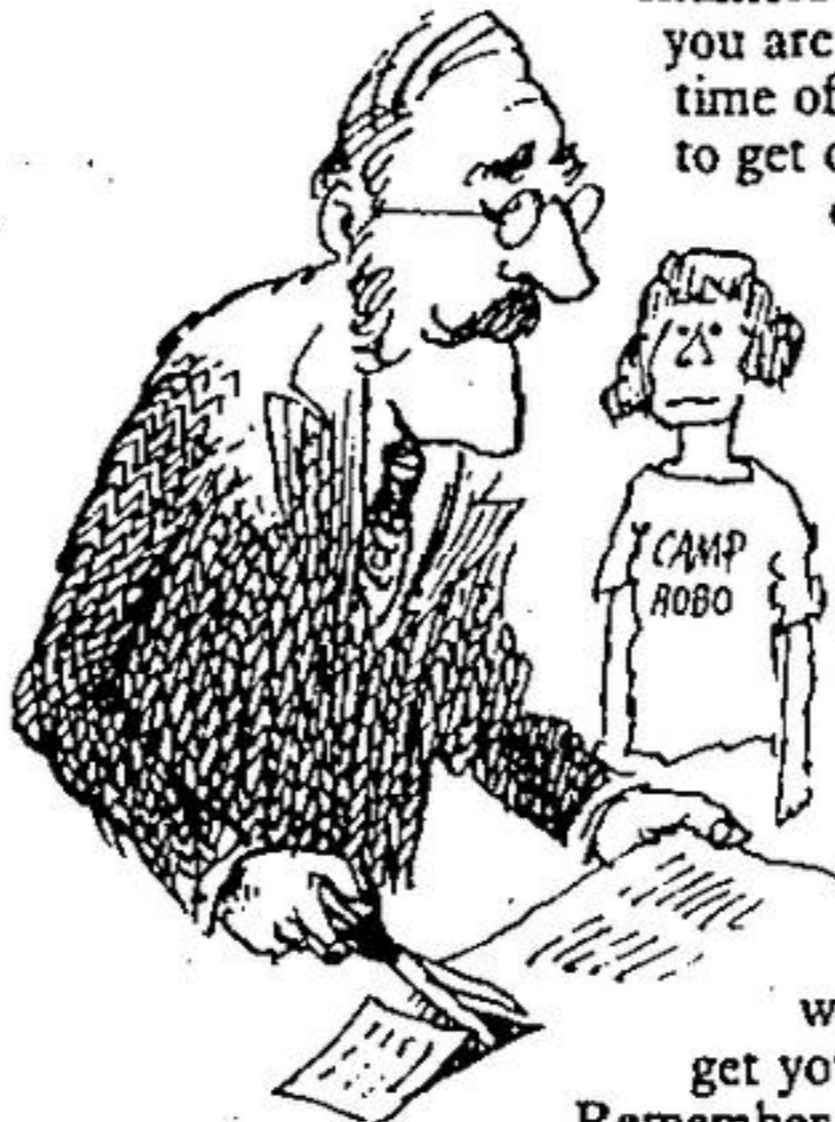

# We're out to get you...

...on the Ontario list of voters.

Who are we? We're the Ontario Returning Officers and our job is to make it as easy as possible, for everyone who is qualified, to vote. By now you should have been enumerated and have in your possession your proof of enumeration, Form 103. If not, and you are qualified or will be at the time of voting, you still have time to get on the list of voters. A qualified voter is a Canadian citizen or British subject, 18 years of age or over, who has lived in Ontario for twelve months preceding Election Day, September 18.



So if you live in an urban area and haven't been enumerated, simply fill in the coupon in this ad or give us a call at your Electoral District number shown and we'll make arrangements to get you on the list.

Remember, a new list is compiled for each election, so even if you have voted before, you must be included on the new list of voters in order to vote in the forthcoming Ontario Election. Deadline for changes or additions to the list is Wednesday, September 10 at 9:00 p.m. EDT.

## Rural Residents

If you live in a rural area, and are qualified to vote, it's much easier if your name is on the list of voters. And there's still time to get on that list. However, qualified rural voters, not on the list by Election Day, may still vote by having a friend or neighbour on the same list "vouch" for them on oath.



## Proxy Voting

If you are a qualified voter, and enumerated, but will be absent from your polling subdivision and unable to vote at the regular or advance polls because:

- you are employed in long distance transportation;
- you are a member of the Canadian forces on active duty;
- you are away attending an educational institution; or, you are physically handicapped and unable to attend a polling place, you may vote by proxy in your Electoral District.

If you wish to vote by proxy, contact your Returning Officer whose number is on your proof of enumeration, Form 103.

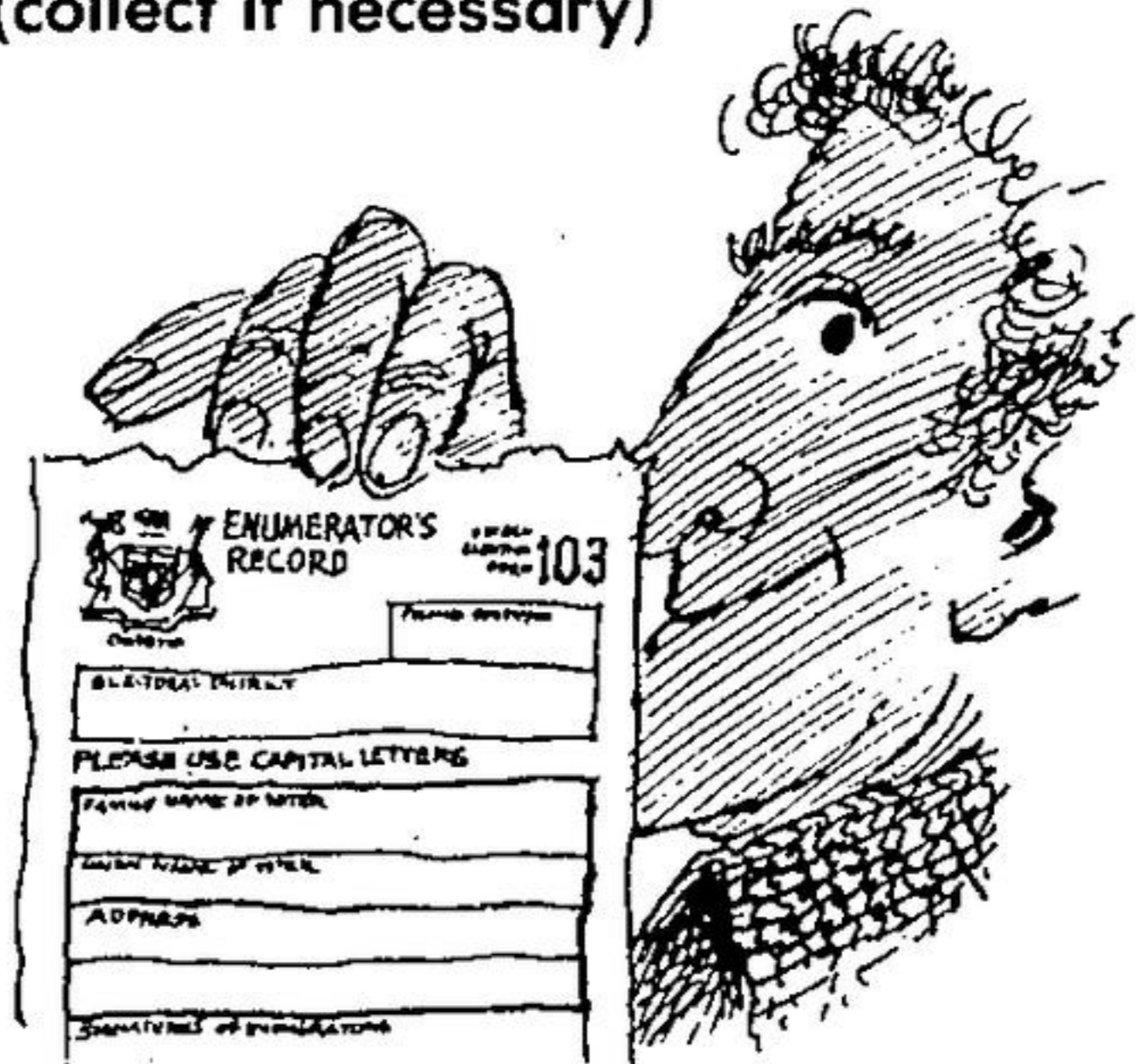
