## Board positions opening

### Focal deal to be discussed

The Georgetown Area Ratepayers Association will hold a general meeting Oct. 19 at 8 p.m. at Centennial Public School on Delrex Boulevard. Heading the meeting's agenda is a report by the Association committee that has been investigating the proposal by Focal Properties Ltd. to develop its lands on Georgetown's southern boundary. While the meeting is open to members only, memberships will be on sale at the door at a cost of \$3 for one year or \$5 for two years.

## Library contributes to fund

The Halton Hills Library Board voted at the last meeting to contribute \$150 to the Canadian Library Association for use on Project Progress, a nation-wide survey conducted by the association aimed at providing a series of upgrading guidelines for libraries. The association has \$125,000 of the \$175,000 needed for the project said librarian Betsy Cornwell. When the request first came to the board some time ago it was turned down because it seemed to have no application to the board, she said. Board member Ken Riley felt that the need for such information existed now however since the board seems to be floundering over its plan with the new or revised building.



#### WHERE?

At Howard Wrigglesworth Public School - on lands to be developed fronting Maple

#### WHEN?

Construction could begin as early as summer 1979.

### HOW IS THIS POSSIBLE?

The Halton Board of Education is committed to upgrading the facilities at Howard Wrigglesworth School by turning the present Resource Centre and building a new Gymnasium · without a stage. BUT the Board of Education is willing to entertain an agreement with the Town of Halton Hills for a joint facility.

#### WHAT IS COUNCIL'S POSITION?

Since receiving the proposal in Spring, Council has Instructed Its officials to investigate the feasability of such a plan and report back. The time for that report to be presented to Council is NOW.

#### WHAT IS THE PLAN?

The Wrigglesworth proposal calls for an L-shaped, two-storey addition to the planned gymnasium. This addition, which would be sealed off from the gymnasium during regular school usage, would contain a full-size stage and back-stage facilities, dressing rooms, make up band room, public foyer, cloak and rest rooms, box-office and refreshment counter. In addition to a lighting and sound control booth, second storey facilities would include a large open area sultable for receptions, group meetings etc. and a gallery running behind the stage which could possibly be utilized for arts and crafts displays, painting exhibitions etc.

## IS THIS A CULTURAL CENTRE FOR ALL THE ARTS?

No. It is primarily a facility for the performing arts - i.e. plays, musicals, concerts, recitals etc. which because it would not have fixed seating would lend itself to a range of town activities e.g. public meetings, dances, arts and crafts shows etc. The final design will naturally be prepared by professional architects with an opportunity for public input.

## WHAT ABOUT SEATING?

A good question. The second part of the Wrigglesworth proposal calls for the installation of custom-engineered collapsible bleachers - with individual theatre-style seats, i.e. Hered seating as in permanent theatre facilities. When not in use, this seating would be rolled away for storage in special lockers at the rear of the gymnasiumauditorium.

## BUT WHAT'S IT ALL GOING TO COST?

The proposal calls for the Board of Education to donate the land for the theatre addition and for paved parking-playground, and to assume responsibility for the construction and outfitting costs of the school gymnasium portion; the Town of Halton Hills to undertake responsibility for the capital costs and construction of the theatre addition, utilizing Wintario and possibly Theatre Arts grants, and the launching of a public fundraising campaign to match government grants in equipping the facilities. It is hoped that a local service club will head such a fund-raising campaign.

## WHAT ABOUT GEORGETOWN ROTARY CLUB PLANS?

The establishment of a multi-use centre for the performing arts has been designated as the club's next community project. Since June the club has been carrying out a Feasibility Study focussing on land availability, the most suitable design to meet community needs, and financing.

## HOW DO THE WRIGGLESWORTH PLANS COMPARE WITH ROTARY'S STUDY?

Basically there is no conflict, i.e. that the Ideal site for such a facility should be central in Wards 3 and 4 (Georgetown); it shoul strive to accommodate as many community cultural aspirations as is practicable; and that construction and future operating costs should not become a burden on taxpayers.

## WHAT IS G.L.T.'S POSITION?

As a community group which has been putting on productions for 20 years now, G.L.T is only too familiar with the needs of the performing arts in Wards 3 and 4 - and the realities of meeting those needs in these days of economic restraints G.L.T. is actively promoting the Wrigglesworth proposal because the group considers it meets the agreed criteria - central site, multi-use plan, and shared financing-operating costs. This is not to say that the Wrigglesworth Proposal is the perfect solution. Naturally, G.L.T as with other performing groups, would prefer to have solely theatre-facilities, with fixed scaling etc. But given present-day economic realities and the lack of suitable available land, the Wrigglesworth Proposal appears to make the most sense for the community as a whole. Moreover It is not a pie-in-the-sky scheme at some future date, but something that can be in operation as early as next year - since there would be no long drawn out debates over land designation requiring O.M.B. hearing etc...

## WHAT CAN YOU DO TO HELP?
