**MIRACLE FOODMART PLaque**

1. Males and females of any age, or a group who have by their efforts and or support made a significant contribution to sports in Halton Hills. Builders of all sports will receive equal consideration. People may be posthumously nominated.
2. Nominees do not have to reside in Halton Hills at present, however their support or efforts had to be directed to helping build sports here.
3. Only people (or groups) whose names appear on the official ballot will receive consideration.
4. Any person is invited to fill out a nomination. However, only signed nominations will receive consideration.
5. One winner and two runner-ups will be selected.
6. A person may win the award more than one year, but the reasons must be different. Runners-up in one year can win for the same reason in future years.
7. The contributions made by the nominees can be from any year, or any period.
8. Ballots received one year will automatically be filed for consideration in future years.
9. Ballots must be mailed or hand delivered to the Halton Hills Herald, 102 Main St. S. Georgetown (area code 709-93) Ontario. Acton Residents can deliver to the Mercury Office at 14 Mill St. E., Acton.
10. Nominations must be received on or before May 14, 1979.
