Former Acton cop breaks probation

A former Peel police detective, ordered to seek psychlatric treatment after being convicted of stealing police property, cannot be located,

according to police. Roy Wood, 42, of Georgetown, was given a conditional discharge by County Court Judge Frank Dunlap, May 6 after he was found guilty of stealing about \$1,000 worth of property from a Mississauga's

division of the force. His disappearance means that the Crown's appeal against the court decision not

to jail him is in limbo, according to a spokesman for the Crown Law Office.

By the time the Crown decided to appeal, within the prescribed 30 days after conviction, Wood could not be

"We've made every attempt to locate him," Insp. Chris O'Toole said.

The appeal papers must be served on Wood by police before the appeal can begin. A 30-day extention was granted in June by the Ontarlo Supreme Court. The court has

period indefinitely until Wood can be served.

O'Toole said he has not checked the Wood's 12-month probation order to see if he was required to report to anyone in the period.




