

Local woman assaulted man, aimed gun at police

Four are convicted over parking lot brawl



Judge Doug Latimer found Linda Burbine, a separated mother of three, guilty of assaulting a civilian, pointing a dangerous weapon and escaping custody during an incident last Aug. 2 in the parking lot of Fong's Restaurant and Tavern on Mountainview Road in Georgetown.

Three Mississauga people also involved in what Halton police termed a "brawl" also appeared before Judge Latimer in Milton provincial court Thursday, Thomas Negus, 27, pleaded guilty to two charges of assaulting police, George Day, 28, to two charges of common assault, obstructing police and assaulting police and Roberta Percival, 25, to obstructing police. The three will be sentenced along with Miss

Burbine March 10. The court learned that Graham Smith of Georgetown was struck on the side of the face. Miss Percival admitted she hit him following a struggle over a loaded .38 Smith and Wesson police revolver taken from a policeman's holster.

According to crown attorney Brian Calhoun, the parking lot disturbance was underway when regional police acting Sgt. Joe Prasad arrived at the scene. Moments later, Constable Joe Martin arrived in time to see Mr. Negus punch Constable Prasad. The three other accused attempted to stop Constable Martin from intervening. Mr. Calhoun sald Constable Martin was then punched by Mr. Negus, suffer-

ing a split lip. During the disturbance, the crown attorney testified, Miss Burbine removed Constable Martin's service revolver from his holster and pointed it at the two officers in turn. Both took cover and Miss Burbine turned the revolver on a gathering

crowd, he said. Mr. Smith testified that Miss Burbine was urged to release the gun by one of her companions before Miss Percival knocked it from her grasp.

"I rushed up and grabbed it with both hands," he told the court. "When it fell, all three of us (he and the two women) went after it." Still holding the revolver,

Mr. Smith said he moved toward the police officers to return it. It was then he was struck in the face by Miss Burbine, whose identity he determined by her build and clothing.

Sgt. Prasad testified that Miss Burbine cried "Stop, stop this" while waving the gun to and fro, but dropped it when her companions tried to restrain her.

Miss Percival, however, told, the court that Mr. Day's sister, Susan MacDonald, was walking toward Miss Burbine while the latter was still holding the

"I turned to look for the police officer, for someone to do something," she said. When she looked back, she saw Mrs. MacDonald and Miss Burbine

both on the ground. Miss Percival said she picked the gun up when it fell and that someone approached her to try and take it. She said she hit that person on the head.

Called as a witness, Mrs. MacDonald told the court she tripped while approaching Miss Burbine and knocked the woman down. MacDonald rose, but said she saw Mr. Smith and Miss Percival wrestling for control of the gun. She said she did not see Miss Burbine strike Mr.

Region rejects advice, picks Site 'F' again

Herald Staff Writer Despite warnings from chief administrative officer Dennis Perlin and the planning and public works committee, regional council last Wednesday maintained that Milton's Site "F" is its first choice for landfilling and that future studies into garbage disposal woes will have to keep that in mind.

Faced with a year-old provincial environment ministry (MOE) order insisting that Halton's landfill site decision must only be made after extensive "environmental assessment" studies, council was advised by Mr. Perlin that its position at future public hearings could be improved If It doesn't "presume" Site "F"

will be its next garbage dump. However, Oakville Coun. Terry Mannell persuaded councillors to reject Mr. Perlin's advice, arguing that at least since 1978, Halton has wanted to turn Site "F" - the 246-acre farm property at the northwest corner of Tremaine and Britannia Roads - Into a

landfill site. "I don't favor Site "F" for the region's landfill site," Coun. Mannell acknowledged. "But the fact is, council has chosen Site "F" several times over. We have had clear indication from Milton town council and the (Tremaine-Britannia Citizens Group) that they are opposed to the idea; yet we have still chosen Site

"I believe that by putting Site "F" into the resolution, it will be incumbent on the region to do a more thorough

job of finding an alternative to it," Coun. Mannell said. But Mr. Perlin advised coun-


Removing Site "F" as the region's first choice, Mr. Perlin admitted, "is a step back", although it may be necessary "if the region is to come out ahead in the long

Meanwhile, the region has ordered staff to look at a landfill proposal from a private firm in Burlington: Part of Site "A", a 180-acre site already considered by some councillors as the region's best option if Site "F" is rejected, is owned by National Sewer Pipe Company


