Obviously, the concerns expressed in our submission had no impact whatsoever.

What concerns us particularly, is a statement by Mr. Miller in his latest letter of Feb. 9 that the new ad valorem fuel tax structure "will assist in shoring up the tax revenue base which is essential in view of the inescapable escalating costs on government expenditures attributable to inΩation".

Does this mean that the provincial treasurer is imposing on the motorist-consumer the responsibility for carrying a substantial portion of total government expenditure and not only those related to highway and road expenditures?

In the provincial tax study carried out by OML Clubs in Ontario in 1980, it was clearly

demonstrated that the motorist was already paying 26 per cent more than the maximum fair share principle enuncialed by the Smith Commission in-

the mid-1960s. This is contrary to a commitment to us by you several years ago that your government did not expect individuals, or groups of individuals, to contribute more than their fair share of the

Our proposal to the Treasurer of the \$10 flat fee was not an absurd one or offered facetiously. It had a basis and a precedent. The precedent is the \$10 flat fee granted to Northern motorists in recognition of the financial cost of operating motor vehicles.

Ontario has approximately 3,850,000 passenger cars. Our latest study showed that the government collected approximately \$160 million in licence

lees from these vehicles. Our calculations on the break down of the current licence fee structure of \$30 for 4 cylinders. \$45 for 6 cylinders and \$60 for 8 cylinders (and \$80 for the extra large 8 cylinders) produces an average of \$47 per automobile.

Depending on the flat fee adopted in 1983, the following revenues would result: \$ 38 million A1 \$10 \$ 76 million A1 \$20 \$114 million

We must recognize, as no doubt the Treasury has already done, that as more and more people move to the

smaller cylinder cars, the average income per vehicle between the current fee structure and the proposed \$48 proposal would increase. For example, people currently paying \$30 for a 4 cylinder would increase to \$48. This percentage of the total vehicle population is expected to increase in the near future, thus resulting in Increased licence fees paid by motorists.

Significant to our proposal are the following facts dealing with the ad valorem gas tax principle currently in effect: Fuel tax paid by the private motorist in the fiscal year

Estimated fuel tax revenues for the fiscal year 1981-82 total s958 million. Forecast fuel tax revenues

1978-79 totalled \$660,900,000.

for 1985 -- \$2 billion plus. With this as a background, I am sure it's appropriate to propose to a substantially lower flat fee for motor vehicle licence fees as a measure of offsetting the very heavy increases in taxes collected by the provincial government from the ad valorem fuel tax. It also seems most approciliation of provincial revenues from the private motorist. rather than attempting to treat each form of revenue as a separate source of taxation.

What I am attempting to show is that our proposal is not a flippant or a naive proposal but one which recognizes that large portions of the burden, and a very heavy inflationary burden at that, is being placed on the motorist-consumers of Ontario, for general government expenditures. This is evident in the second last paragraph of Mr. Miller's

letter to us of Feb. 9. No other commodity or service has had such a rapid escalation in price, including such a heavy increase in the total burden of taxation paid by motorists, through federal and provincial tax policies.

Surely It is appropriate that the motorist-consumers of Ontario should look to its provincial government for relief, even though part of the responsibility is that of the federal government. The 3,800,000 private car owners represent a very substantial percentage of wage earners in Ontario, many of whom are priate that there be a recon-




