To cope with the heat, the delegates had to keep moving, she said. Waving the signs was one tactic to battle the stagnant and hot air, she said.




"I was talking with Alan Eagleson from the Clark camp and I said three-quarters of Crosble's support would go to Mulroney," she said.

Auto wreckers

Stockpiled cars violate bylaws?

A proposed hearing into bylaw violations by two Halton Hills auto wrecking firms will wait until the town's bylaw enforcement officer has submitted a report to town counc-

Itself an unusual step for councillors to take the hearing was proposed by Esquesing rep Pam Sheldon following a vehement call for action against Hallon Auto Wreckers of Limehouse by neighboring residents.

They say that, despite warnings from the town's bylaw officer and conditions attached to the firm's operating license last January, the firm continues to violate town bylaws on which the permit is based.

Following council's January conditions there was a "great flurry of activity in the wrecking yard", residents' spokesman Mary Shier told the town's general committee Monday night.

But, she added, "It did little to remedy the problem of stockpiling the cars".

"They're still much higher than the fence," she said, "The community has been more than tolerant; the time has come for action."

However, lawyer David Page, representing Halton Auto Wreckers, said that his client has been the victim of persecution from residents over "a very long period of time".

A June 2 letter written to wrecking yard owner Fred Tolten by bylaw enforcement officer Jack Lusty maintains that the fence around the wrecking yard is up to bylaw standards.

In addition, Mr. Page said, vehicles parked outside the fence are licensed and a part of the firm's day-to-day operations.

The stockpiling problem, he added, is not a new one, but tends to "come and go with the economy".

Mr. Lusty has explained that wrecking yards have found it difficult to get rid of scrap metal during the recession.

"The problem is really a social one," Mr. Page said. "We don't like wrecking yards but we have to have them."

As of that (Monday) afternoon, residents said, cars were still too high above the fence, violating the bylaw. "In tough times," Mrs.

Shier asked committee. "does it mean bylaws are meant to be broken, badly bent or, for a pun on words, scrapped?" The fence surrounding

the yard, she said, is a "hodge-podge of dilapidated boards and rubble." Mrs. Shler maintained

residents have tolerated problems at the wrecking yard, located above the southeast corner of the Fifth Line and Regional Road 43, for 13 years. Halton Auto Wreckers,

she added, has shown "an obvious Indifference and outright defiance for

With due notice, town clerk administrator Ken Richardson told committee, the committee can hold a hearing as a judicial body, determining whether or not to revoke the operating permits of businesses violating bylaws.

But Coun. Mike Armstrong successfully argued against a hearing until Mr. Lusty, who is recouperating from an Illness, has submitted a report on

the wrecking yard issue. Coun. Sheldon had hoped to hold the hearing June 27.

Coun. Harry Levy pointed that one other wrecking yard, Watson's Auto Wreckers, has yet to paint its fence, although it was warned to clean up in January.

Watson was included in the scope of the proposed hearing.

Uncle jailed

A Georgetown man who pleaded guilty to wounding his nephew was sentenced to eight months jall followed by 12 months probation and abstinence from alcohol consumption, Tuesday morning.

Michael Blake Ryall, 37, was sentenced in Milton provincial court by Judge W.S.Sharpe for stabbing his 24-year old nephew with a knife Dec. The domestic dispute

arose out of mutual drinking and jealousy over a woman, defense attorney Jack Bellegham told the court.

He called it "extremely unlikely" the circumstances would arise The defense lawyer

suggested a three-month jail term with a nondrinking clause would be adequate, as it was an Isolated incident occurring during a drinking

Judge Sharpe agreed that the behavior was out of character for Mr. Ryall, but said the aspect of deterrence had to be considered.

Mr. Ryall has since moved to Smiths Falls.

Funding for landfill site

In its efforts to get funding from the province to finance its search for a new landfill site. Halton has talked with Tory MPPs James Snow and George Kerr; but there hasn't been much contact with Halton-Burlington's Liberal MPP Julian Reed.
