## Design report okayed

Council rejected the decision they made in general committee last week on Wildwood Road, and voted instead to go along with the town engineer's recommendation to finish off the \$45,000 Preliminary Design

Report on Wildwood. The "Preferred Plan" for Wildwood, which states specific works to be done on the central, cast and west sections of the road between Confederation and Eighth Line, has been received for inclusion

in the Preliminary Design Report. As Engineer Bob Austin explained several times last week and this week, this does not mean any of the work will be undertaken. The report only sets out guidelines as to what improvements could be made. The decision to go ahead and do any of these improvements rests with councillors and the dollars they choose to allocate in their annual budgets.

A motion by Coun. Pam Sheldon that Wildwood be considered for maintenance at budget time was approved. Her other motions that would have put a stop to the Preliminary Design Report weren't. Last week's motion by Coun. Joe Hewitt calling for additional in-

formation on works to the central and east sections of Wildwood would have cost an extra \$14,800 and was overturned in Monday night's council meeting. The Hewitt decision took 314 hours last week, and Monday night's decislon another two hours. Further

discussions on Wildwood will likely

be limited to the budget committee talks which are underway now. "To derail the thing (Design Report) at this time doesn't make a lot of sense," Coun. Norm Elllott objected, saying it would be "a. little foolhardy" not to finish it when it

was 90 per cent completed. Mr. Austin said the \$45,000 for the Preliminary Design Report included background work by CC Parker Consultants Ltd., a solls investigation, public meetings, brochures, meetings with staff and general committee, and a recommendation

for a "Preferred Plan". The Report only needs the council recommendation to wrap it up now, he said.

Coun. Norman Elliott said the decision to spend any further money on Wildwood Road after the study is finished would likely be by future

Wildwood residents have said they don't want their road widened or upgraded, and especially, that they don't want any roadside trees cut.

Council liability was referred to by the town engineer. It's important the town end up with a preferred plan, the town engineer said.

"The main reason is, the town hired a firm with a very competent traffic engineer who has signed a document that says, whether you agree with it or not, that the road is not safe," Mr. Austin warned. "To not complete the report leaves that statement hanging."

Council is better off to complete the report and then deal with improvements to Wildwood according to its financial priorities.

"As I best understand it, you're in a better liability point of view to complete the study," he said.

Since mid-1982, Halton has been conducting an Environmental Assessment to identify appropriate methods of providing waste facilities. Hallon has concluded that as part of its waste management system, it requires sanitary landfill capacity for approximately 7.96 million cubic metros of waste during the period 1988 to 2008

Site D is comprised of Lot 3, Concession 2 and part of Lot 4. Concession 2 in the Town of Milton, in the Regional Municipality of Halton, formerly in the Township of Trafalgar, in the County of Halton

Sile F in the City of Burlington is located north of Highway 403 on the northeast corner of the North Service Road and King Road. It is bounded on the west by the existing Region of Halton Landfilt, and on the northeast by Bayview Park. The proposed site is approximately 96 hectares. Site F is comprised of parts of Lots 2, 3 and 4. Concession 1, part of Lot 3, Concession 2, and part of the road allowance between Concessions 1 and 2 in the City of Burlington, in The Regional Municipality of Halton, formerly the Township of East Flamboro in the County' of Halton Location of the sites D and F are as shown on the map


