

Struck car

A 27-year-old Georgetown man was charged after he rear ended a car on Thursday at 6:25 p.m. He was driving his 1979 Chrysler on Guelph Street when he struck the car ahead of him which stopped at the corner of Maple for the red light. He caused \$750 damage to his car.

Hit hydro pole

A 17-year-old male has been charged after he struck a hydro pole on Steven's Crescent Saturday at 8:35 a.m. He was travelling east on Steven's Crescent when he took his eyes off the road to adjust his car radio. His car ran off the road and hit the pole. Damages to his 1985 Mercury are estimated at \$2500. The pole is valued at \$250.

Awnings slashed

Minor injuries

The second driver drove off after the collision. The was treated and released from Guelph General Hospital.

A 16-year-old Erin girl has been charged after she struck a vehicle while making a left turn from Guelph Street on to Alcott Street Thursday at 3:03 p.m. She hit a 1986 Chevrolet at the intersection causing \$1100 damage. The driver of the last car, a 1976 Austin, told police she thought she had a flashing green light. Damages to her car are estimated at \$2500.

Darryl McLean, 24, and Shayne Rand, 22, both of 52 Queen St., were travelling north on 10th Line when they drove past No. 20 Sideroad and turned back to make a right turn. The driver lost control of the car and skidded across the road. The car landed in the ditch after hitting a tree. Police said the car also may have hit a stop sign. Damage to the car is estimated at \$4000.

Area One firefighters were called to rescue the two men from the car. Both were taken to Georgetown and District Memorial Hospital.

Charges are pending, police said.

Mr. McLean was treated and transferred to Toronto Western Hospital. Shayne Rand was admitted for observations with a head injury. He is listed in satisfactory condition in Georgetown and District Memorial Hospital.

Residents want action on McGilvray Cres. flooding

Halton Hills town council learned of major flooding problems on McGilvray Crescent Monday but no action will be taken on the problem until at least October capital expenditure forecast discussions.

Gordon Hoyle, a resident of McGilvray Crescent appeared before council Monday to urge members to fulfill years of promises to do something about the flooding.

After a rainfall some residents are "living on the shores of beautiful lake McGilvray," Mr. Hoyle said.

Mr. Hoyle said many of the 100 families on the street are original residents who moved in in the late 1950's and promises 30 years ago to do something about flooding on the street have not been carried out. "People are very upset. I've spoken to everybody on the street. There is always six inches of water after rain," he said.

Mr. Hoyle said he spoke to town engineers in 1982 and was told the problem would be rectified in three or four years. A neighbor spoke to the Mayor who said the street would get curbs this year, Mr. Hoyle said.

"Many of the neighbors have put gravel in front of their houses at their own expense. I've just spend

\$300 repairing my basement," he said.

Town engineer Bob Austin said some shovelling has been done on McGilvray but not very much.

Residents on McGilvray resorted to circulating a petition which council received May 25.

Mr. Austin said the initial engineering would cost \$10,000 to \$15,000 but complete reconstruction of the entire road could come with a \$300,000 price tag.

Despite the repeated complaints, Mr. Austin said McGilvray Crescent has never been included in the capital expenditures forecast.

But councillors are attempting to put the flooding problem on McGilvray Crescent into perspective with other road needs in Georgetown. "If people are getting flooding we're dealing with the same thing on Balfour (Crescent) and we were dealing with the same thing on Byron (Street)," coun. Betty Fisher said.

"We have been putting these projects off for a number of years," Mayor Russ Miller said.

Coun. Marilyn Serjeantson said there are plenty of roads in Ward 4 "which don't stack up to the condition of the roads in the other wards."

Mayor Miller pushed for a town engineer's report on the condition of roads in Georgetown to "make sure this (McGilvray) fits into the right position."

Work on McGilvray Crescent will be up for debate in the 1988 budget discussions but it will be approached first in the capital expenditures forecast in October.

Funding for town complex is approved

Funding for the \$5.3 million new municipal building was approved by the town General Committee Monday.

Just over \$1 million would come from the administration building reserve fund, \$3.1 million would be drawn from loans and the municipality would sell off \$1.16 million worth of excess lands to fund the rest.

The funding must now be approved by the Ontario Municipal Board.
