Although the Halton North riding was created only recently, it is interesting to compare voting decisions since 1975 in Halton-Burlington.

Although the Liberals held Held Halton-Burlington from 1975 through to 1987, each election was closely

Julian Reed, in three elections over ten years defeated his Progressive Conservative opponent by less than 520 votes on two occasions.

In 1975 NDP candidate William Johnson collected 6,567 votes: PC candidate Gary Dawkins received 10,535 while Mr. Reed won with 10,998 votes. The Liberal MPP won his first election with 39 per cent of the vote and by 463 ballots.

In 1977 William Johnson for the NDP slipped to 5,598 votes while PC candidate George Gray collected 10,287. Julian Reed won the election with 13,985 votes. He won handily by some 3,698 votes.

The 198t election was a different story. The NDP candidate Chris Cutler received 3,500 votes, Fran Baines for the PCs had 12,877 and Julian Reed for the Liberals collected 13,395 votes. The incumbent was returned by only a 518-vote margin.

In the 1985 election, Don Knight was acclaimed as the Liberal candidate when Julian Reed retired. He won the May contest, garnering 14,906 votes compared to PC candidate Peter Pomeroy, who collected 14,727. NDP candidate Doug Hamilton received the support of 4,902 voters. Only 179 votes separated the Liberal and Conservative candidates.

Students can vote away from home

Students who are qualified electors and duly registered at a recognized educational institution away for their ordinary residence are eligible to vote by proxy in Ontario's 34th provincial general election on September 10.

Whether voting in person or by proxy, it is the responsibility of students to ensure that their names are on the list of electors for the polling division where they normally

Proxy voting allows an elector to authorize another qualified elector in the some electoral district to vote on their behalf. A qualified elector may not act as proxy for more than two electors.

Proxy application forms may be obtained from any Returning Officer throughout the Province. Once completed, the form must be presented to the Returning Officer in the electoral district where the student

Upon receipt of the proxy application form, the Returning Officer may then issue a certificate to the proxy voter who will, in turn, present it at the polling place to exchange it for a ballot.

Persons eligible to vote in this election are those who, on election day, are 18 years of age or older, a Canadian citizen, and have resided in Ontario for the six month period prior to election day, and whose names are on the list of electors or on a certificate to vote in the electoral district where they reside.


