Town sits on the fence over height restrictions

Restricting the height of fences and hedges in Acton may create more problems than it is worth, according to councillors and by-law en-

forcement officer Bob Ustrzycki. "You can't legislate people's taste," said Pam Sheldon.

On Monday, town council addressed a petition by residents living near Poplar Avenue, where an eight-foot fence with a top layer of barbed wire has been erected in front of a home. When the petition was first

presented to council, at the end of June, councillors asked Mr. Ustrzycki to amend the current fence by-law to include Halton's rural areas.

But, residents near 100 Poplar Avenue want the new fence torn down and another law passed which would prevent any such fences being built in the future.

The by-law enforcement officer told council that a new law restricting residential fences to six feet would affect a number of current fences in town. Since rumors of new fence restrictions started, Mr. Ustrzycki has answered nine calls from concerned residents, he said.

The alternative is to pass a law restricting any such fences in the future, but it would not solve the Popular Avenue problem, he

"The fencing issue has placed the municipality in a Catch 22 position," Mr. Ustrzycki said. Acton councillor Norm Elliott sald

he is concerned about the council becoming too restrictive. In the City of Etobicoke, he said, there are restrictions on grass length.

"Everybody laughs at it, but it is an example of how regulatory a municipality can be, Mr. Elliott sald. "We'd be opening up a real Pandora's box." Councillor Gerald Rennie agreed

with Norm Elliott and added that the current Popular Avenue dispute should not involve town council Passing a law is a "heavy banded" way of settling the matter, he said.

Council decided it would restrict only those fences which pose a health or a safety hazard to the com-
