Revisions in Town's confidential procedures

Council is going to change the way it deals with confidential resolutions in light of recent accusations of improper conduct by real estate manager Finn Poulstrup.

The Town's decision to hire consultant Stephen Saxe Ltd. to help market 15 lots on Princess Anne Drive "does not appear correct and honest", Mr. Poulstrup told councillors Monday.

Councillors reacted cautiously to that claiming the unreleased motion was simply an oversight.

From now on town staff will print on confidential minutes that the motions will be released to the public once they are approved by council unless otherwise Indicated.

Councillor Betty Fisher didn't want to see it done that way. She preferred to make the confidential motions public as councillors see them arise.

Lack of Halloween pranksters

Police in Georgetown are surprised at the relatively few reports of vandalism over the Halloween weekend.

Staff Sergeant Keith Robertson said damages and break-andentries had not increased from the rest of the year.

"Council has run its own tender in the past and it must have found tendering land for sale unsatisfactory otherwise it would not have chosen to hire an outside agency to market its Real Estate." Mr. Poulstrup said.

"Why then did you hire someone with limitations you have found to be unsatisfactory for yourself?"

"There have been many questions that have been brought up that I couldn't answer," Coun. Betty Fisher said.

"It is suffice to say that we're here to represent the interest of all taxpayers and not just the interests of ourselves or of any particular group," she said.

Confidential resolutions arising out of an "in camera" meeting are sometimes released to the public and sometimes they are just approved without being spelled out, Coun. Fisher said.

"In this case I don't know why it didn't come out in public," she said, "It was not the intention of our committee to snub the industry," said Coun. Pam Sheldon who is also the chairman of the MOPS commit-

"I want to assure you Finn that you're going to get some answers," she said.

The MOPS committee is expected to meet in a closed session within the

Police beat

Man charged

A Georgetown man has been charged following an accident which occurred on Guelph Street Saturday morning. Two cars, travelling east on Guelph Street, collided when the driver of a car in the curb lane changed lanes and struck the car travelling in the centre lane. Damage to the first car is about \$250 and the second car sustained about \$1,200 damage, police said. The driver of the first car, a 45-year-old male, was charged with making an improper lane change.

Improper turn

A 44-year-old Weston man has been charged after he struck a car while making a turn off the Fourth Line onto 17 Sideroad Wednesday at 12:30 p.m. A Shelbourne man, 35, was driving his 1979 Pontiac along 17 Sideroad near the Fourth Line, when he stopped at the intersection to wait for a tractortrailer to complete a left turn onto 17 Sideroad. The driver of the rig cut the turn too closely, police said. The left wheel on the trailer clipped the front left corner of the Pontiac, causing \$1,000 damage. The truck driver has been charged with making an improper left turn.

Collides with truck

The driver of a road grader, belonging to the Town of Wellington has been charged as the result of an accident which occurred Friday at about 10 a.m. A 22-year-old Belfountain man was driving a 1982 Pontiac east on 32 Sideroad when he saw the road grader coming the opposite way in the wrong lane. He tried to slow down but he could not avoid a collision, police said. The driver of the grader is a 31-year-old Guelph man. Damage to the Pontiac is about \$2,000, police said.

31 windows smashed

Between 8 p.m. Saturday and 9 a.m. Sunday, 31 windows at the Park School on Hyde Park Drive were broken, for a total damage of about \$3,000. A bat or similar object appears to have been used, police said.

Rock thrower

Someone threw a rock through the front window of a 1979 Chevrolet Impala while it was parked at 298 Arthur St., Acton on the weekend. The damage occurred between 11 p.m. Saturday and 10 a.m. Sunday. The window is valued at about \$200, police said.

Parking enforcement receives new powers

The Town's General Committee voted Monday to expand the powers of the parking enforcement officers. Currently the officers can only enforce parking violations in the

business Improvement areas of Halton Hills and in handicapped parking spots and fire routes. All other parking occurrences or complaints are investigated by the

Halton Regional Police Force, said Bylaw Enforcement Officer Bob Ustrzycki. If council adopts the recommendation next week the parking officers' powers will be expanded to that of

"Municipal Law Enforcement Of-ficers" which allows them to enforce all parking regulations within the Town of Halton Hills. The move is in response to a Halton Regional Police study which says bylaw classed occurrences being reported to police are increasing

by 20 per cent annually. Increased urbanization has resulted in more noise and nulsance complaints and parking problems,

the report says. "All municipatitles should relieve police of certain duties in respect of bylaws so that trained police officers' time could be used more wisely to benefit the community." Mr. Ustrzycki said of the police

Smoke discovered behind Acton Y

Firefighters were called to investigate smoke coming from behind the YMCA building in Acton Saturday at about 9 p.m. They found the cause to be a pile of burning leaves.

On Sunday, firemen responded to two resuscitator calls at about 5 p.m. and 10:30 p.m. The first was a male victim suspected to be suffering from appendicitis at 164 Longfield Road. The second was a female having problems breathing at her home on Willow Crescent. Firefighters administered oxygen to the victim until ambulance attendants arrived.

The Georgetown Volunteer Ambulance asked for the help of firefighters Monday at 9 a.m. when a male fell into the basement of a home under construction. The man had broken his leg. Ambulance attendants and firefighters had to hoist the victim to ground level because no stairs had been built in the house. The building is located on 15 Sideroad.
