DEAR GRANDPARENTS - See a lawyer who specializes in family law. If you haven't already done so, sue for permanent - or at least temporary - custody of Beth. Drug addicts can charm the birds out of the trees when they want to, but your bottom line is saving Beth.

Drug use and pushing are crimes for which Elise could be arrested and either jailed or forced into a mandatory rehabilitation program. Pray this happens. It's your daughter's only hope.
