# Police beat

### Mazda demolished

A 1988 Mazda rolled over and was demolished as a result of an accident at Trafalgar Road and Seventh Line last Wednesday. Police say a 1965 Cadillac, northbound on Trafalgar Road, attempted to pass the Mazda which was making a left turn into a private drive when the cars collided. An Esquesing man, 77, is charged under the Highway Traffic Act. The driver of the Mazda, a Mississauga man, was treated at Milton Hospital, and released.

## Man charged

Canada Packers wants to preserve water levels in the lake to ensure good servicing to its lands which are scheduled to be redeveloped.




