

Young rider injured in hit-and-run

A 14-year-old Georgetown girl was struck by a hit-and-run driver while riding her horse Friday afternoon. Tanya Mitchell was "just coming along the road... she was almost home," said her mother Pam Mitchell, when Tanya and her horse were hit by a truck and knocked into the ditch at the side of 10th Line, north of Glen Williams.

"She's got a very serious leg injury. The car basically sideswiped her and the horse," said Mrs. Mitchell, of her daughter who was first taken to Georgetown and District Memorial Hospital, and later transferred to the Hospital for Sick Children in Toronto.

Police say the vehicle is "believed to be a pick-up or four-wheel-drive vehicle, silver-grey in color."

Evidence at the accident scene indicates that the make is Nissan, and there could be a roll bar on the vehicle. The truck has orange trim in the bumper area and damage to the right front corner, say police.

Mrs. Mitchell says Tanya often rides her horse on the same route from 10th Line near Clayhill Road, and that "the whole neighborhood knows her." This is the first time Mrs. Mitchell has heard of such an incident in the area.

Police say the horse was injured in the accident, but "he will live."

Halton Regional Police are asking for public assistance in finding the driver of the hit-and-run vehicle. Anyone with information can call the Regional Traffic Bureau at 878-5511.

Conservative victory 'something historic'

It was a relatively calm Garth Turner who graciously accepted victory at the North Halton Golf and Country Club Monday.

Calm - in contrast to his victory for the nomination as the PC candidate in Halton-Peel five months ago when he left out of his chair in jubilation when the final results were announced.

He was declared a decisive victor just 55 minutes after the polls closed.

Mr. Turner, who watched the results at his Campbellville home with his wife Dorothy and his parents, entered his victory party at the club scant seconds behind Liberal candidate Pierre Klein. The two met in the hallway and exchanged a few brief pleasantries before entering a packed hall of cheering Tory supporters.

"I think tonight we've done something great, something historic," Mr. Turner began.

"I really don't consider tonight to be a victory but more that I've been given a trust," he said in reference to his boundless support of the free trade agreement.

Calling his victory "a humbling experience" Mr. Turner revelled in telling supporters parliament will soon be recalled and the free trade deal will be passed by his majority government.

He acknowledged that "campaigns can get nasty and things can get said" that otherwise wouldn't, but he congratulated Mr. Klein, New Democrat Fern Wolf and Libertarian George Panagapka, whom he termed "delightful."

The other candidates "breathed some more life into the political process by getting more people involved," said Mr. Turner.

He later admitted the intensity of the campaign weighed on his mind.

"The name-calling bothered me, the (incorrect) statements bothered me, the allegations, the signs spray-painted with dollar signs in my eyes bothered me," he said.

"That was hard to take."

About fighting opposition "scaremongering" surrounding the free trade deal Mr. Turner said, "It's awfully hard fighting powerful lies. It only takes a few seconds to lie to people and it takes a long time to calm them down" - a refrain he used repeatedly during the many all-candidates debates in the riding.

Mr. Klein was also gracious in defeat, burying many of the bitter words uttered between the two during the debates.

He congratulated Mr. Turner at 9:45 p.m.

"Canadians have made up their minds in the greatest question that has been asked since 1911," said Mr. Klein.

"The people of Canada have made a decision. I respect that decision."

Ms. Wolf appeared at the club at 10:45 p.m. to a warm applause from Tory supporters.

"I appreciate the friendship that you've extended and I congratulate you on the campaign that you have run," said Ms. Wolf.

Mr. Turner said the constituency office on Guelph Street in Georgetown would remain open.

He pledged to set up a series of constituency advisory groups to discuss the environment, taxation and implementation of the free trade deal.

He also vowed to bring senior party members to the riding to discuss issues.

"What I want is a bridge between our riding and Ottawa. I don't want to run away and hide in Ottawa," said Mr. Turner.

The victor also said he plans to hold a series of "town hall meetings" across the riding regularly to discuss issues.

Asked about a possible cabinet post Mr. Turner said: "I haven't talked to anybody about anything more than being a member of parliament."

"For me, when I walk into the House of Commons it's going to be an absolute thrill."

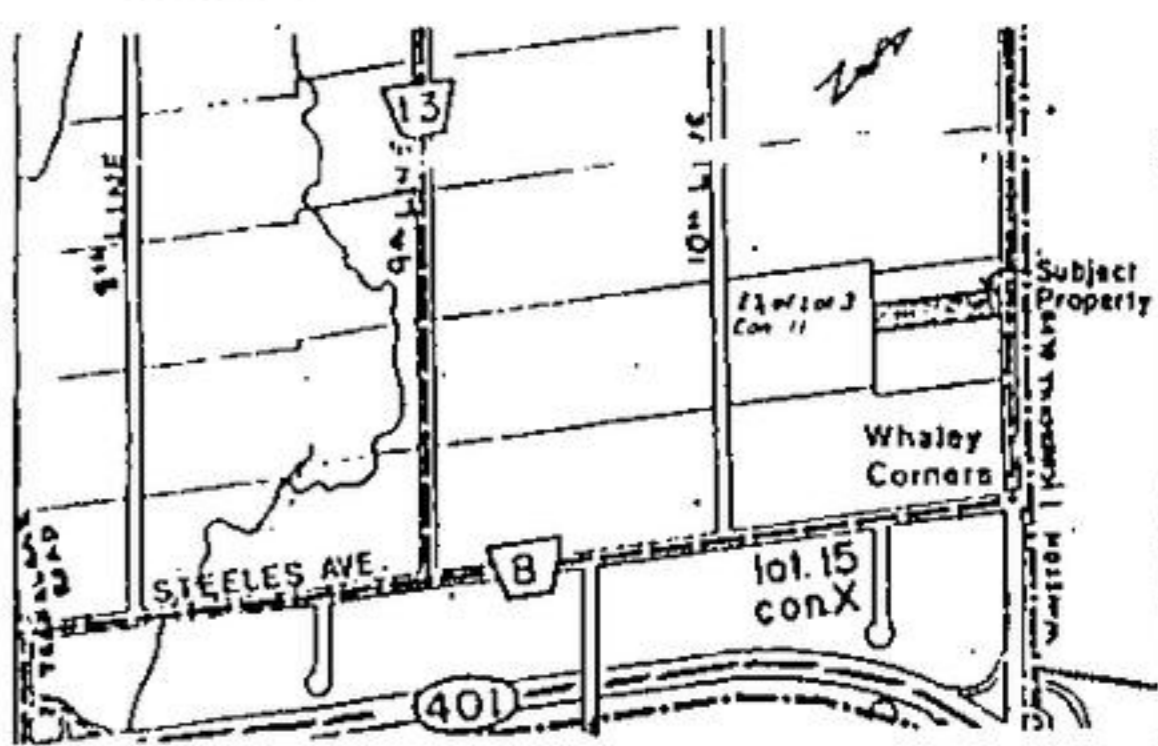

Police beat

Man charged

A driver, apparently answering a car phone Tuesday morning swerved into the wrong lane and struck an oncoming car, according to Halton Regional Police. Police say a 1988 Pontiac, driven by a Georgetown man, 30, collided with a 1985 Plymouth driven by an Acton woman, 35, on Sideroad 15 near Trafalgar Road. Both cars received severe damage, but no one was injured. Police have charged the Georgetown man under the Highway Traffic Act.

Moderate damage

A 1970 Chevrolet received moderate damage when it was struck by a Mack tractor Wednesday morning on Steeles Avenue near Trafalgar Road. Police say the Mack was backing into a construction site and did not see the car. An Uxbridge man, 31, is charged under the Highway Traffic Act. The Mack driver and the driver of the Chevrolet, an Acton woman, 20, were uninjured.

Vehicles collide

A Georgetown youth, 17, was charged with failing to stop after his 1987 Ford struck a 1981 Celica driven by a Mississauga woman, 21, Sunday night. Police say the Ford was westbound on Prince Charles Drive near Windsor Road when it failed to obey a stop sign and struck a northbound Toyota. The Ford was moderately damaged and the Celica received severe damages, in the collision. The Mississauga woman, 21, was treated at hospital for minor injuries, then released.

Drivers charged

Two drivers were charged in a Guelph Street collision Tuesday night. Police say a 1984 Pontiac driven by a Georgetown woman, 74, was eastbound on Guelph Street when it struck a 1983 Ford in the intersection. Both cars were lightly damaged in the collision. The Georgetown woman is charged under the Highway Traffic Act. A Georgetown man, 19, is charged with driving while under suspension. He received minor injury in the collision.

Tarp taken

Police say a tarpaulin 33 ft. wide and 10 ft. long was taken from a Limehouse property Friday night. The tarp, valued at \$450, is brown with yellow ropes and bears the brand name Searle. It was used to cover a tractor trailer.

\$500 damage

A 1975 Mercury Bobcat received \$500 damage when it was pushed over an embankment at Georgetown District High School sometime last week. Police say the car received a broken window, and front windshield and damage to the rear bumper.

Friends of late Georgetown resident and mother JoAnn Watson, 32, are asking for contributions to a trust fund for her three children.

Leslie, 9, Scott, 8, and Julie, 6, became orphans last week when their mother died suddenly of a heart illness.

"It's not been an easy life for her," said her employer of 12 years at the Somersplace Restaurant in Huttonville, John Thomas. "She had just bought a townhouse and was getting her life together when this happened."

Mrs. Watson died Nov. 14 after suffering a weekend of "massive brain hemorrhaging." Her heart stopped beating, said Mr. Thomas.

At the funeral, conducted by Rev. Peter Barrow of Georgetown, mourners shared their grief for the deceased single mother, but also mourned for her children.

"People who didn't even know her want to help the children," said Mr. Thomas. "She was a wonderful, wonderful person... she never complained although she had more than many people have to complain about," he added.

Mr. Thomas, in conjunction with the Royal Bank in Brampton and the Main Street, Georgetown branch, hopes to raise \$25,000 in trust for Leslie, Scott and Julie, to provide them with an education.

"She would have wanted them to have a better quality of life than she had struggled with," he said.
