Equipment missing

Halton Regional Police estimate \$800 in goods was taken from a locked car in Acton the weekend of Dec. 3 and 4. Mayor addresses Chamber and gives vision of future

Georgelown will retain its small town identity despite plans which call for expansion to 40,000 people in the next 10 to 15 years, Mayor Russ

Speaking at a Georgetown Chamber of Commerce luncheon Monday, Mayor Miller said the speed of the increase in population from the current 18,000 in the urban Georgetown area, will depend on the demand.

"When I came to the Georgetown area there was 3,000 people here. It was a lovely little town at 3,000, it's still a lovely town at 18,000 and it will probably still be a lovely town at 40,000," Mayor Miller said.

The development will blick off next year with 500 homes in Halton Hills Village on the east side of the Ninth Line, he said.

And the expansion to Georgetown's sewage plant should be finished sometime next summer to allow development in the area to meet demand, he said.

There are also 400 acres of industrial zoned land at the southern end of Halton Hills Village, Mayor Miller said.

The town has been pushing to attract more industry recently in an attempt to balance the residentialindustrial assessment base to ease the tax burden on homeowners.

The Highway 401 corridor is another desirable place for industrial development, said the


Development will likely come from the east and locate in that area,

he said. "It's only a natural." That 400 acres of industrial land in Halton Hills Village will be servicable next year, said Mayor

Miller. But there likely isn't going to be large-scale commercial growth, he said. "Most business people feel there is a large amount of commercial development in Georgetown. We didn't want to flood the market with


any more." Mayor Miller wants to develop a secondary plan for the older urban area of Georgetown. The town is getting applications to redevelop portions of property in older Georgetown so a secondary plan could give it direction, he said.

Chambers move on with amalgamation

Barring any last minute objections, the Georgetown and Acton members on the board of directors Chambers of Commerce will officially amalgamate Jan. 28.

The Halton Hills Chamber of Commerce will officially begin operations on Feb. 1.

The 65 members of the Acton chamber of commerce voted "overwhelmingly" in favor of amalgamating with the Georgetown

chamber at the end of November, according to Georgetown Chamber president Murray Lawton. The Georgetown Chamber won't have a full vote of its members similar to the Acton vote. Instead, the board of directors will be asked

which allow the amalgamation. Mr. Lawton will remain as the head of the new Halton Hills Chamber of Commerce and Acton president Mike Manes will take a vice-president position alongside the two Georgetown vice-presidents.

The members of the Boards of Directors from the two chambers will then merge to form the Halton Hills Board of Directors until May, when a new and likely smaller board of directors will take over the Halton Hills Chamber June 1.

Manes sees big benefits

Acton businesses stand to gain from the amalgamation between the Acton and Georgetown Chambers of Commerce despite claims by a handful of businessmen the town will get "lost in the shuffle," Acton chamber president Mike Manes

Only three businesses out of 65 members voted against the merger in the November vote, sald Mr. Manes.

About 90 per cent of the members actually voted, he said. Mr. Manes said he considers the vote a convincing mandate to amalgamate with the Georgetown chamber.

Together, the two chambers will represent over 300 businesses throughout Halton Hills.

Mr. Manes believes Acton businesses will be more organized with more time for other functions with the help of Georgetown's resources, which include a fulltime staff worker and a computer.

And Acton will have a larger voice when making requests of other bodies because the requests will come from all Halton Hills businesses, Mr. Manes said echoing what Georgetown chamber members have said in the past.

Opponents to the merger complained that Acton might "get lost in the shuffle" but Mr. Manes says Acton businesses will get stronger as a result of the merger.

Acton businesses have a good relationship with the Georgetown chamber and Acton members of the new Halton Hills board of directors will have no difficulty keeping an eye on Acton issues, he

Currently Georgetown has 25 and Acton has nine. The actual number of Halton Hills Chamber directors elected will not be specified and the chamber will elect as many as it feels is necessary each year, said Mr. Lawton.

The Halton Hills Chamber will be able to use the services of Georgetown's fulltime general manager. Doug Penrice, so it likely won't need as many board members as it will carry until June, he said.

The idea is to create a chamber which will be able to lobby government organizations with a unified voice. Representing only Georgetown put roadblocks in the to vote Jan. 10 on changes to bylaws way of chamber requests from various levels of government, said Mr. Lawton.

And Acton businesses will be able to use the more extensive resources and knowledge the successful Georgetown chamber has gathered over the years, including documenting information on a computer, said Mr. Lawton.

Although the chambers will operate under a single banner from February on, Acton chamber members will have to play an active role in the organization in order to make sure the chamber retains a vibrant role in the smaller town, said Mr. Lawton.

Georgetown members are prepared to support Acton activities but "nobody from Acton's going to come in and do something for Georgetown and vice versa," Mr. Lawton said.

Now, instead of Acton members using their time just trying to organize a chamber, they can channel their efforts to events and allow

the Halton Hills chamber to take care of the administrative work,

said Mr. Lawton. One of the first issues the new chamber will tackle is garbage collection for area businesses, said Mr.

Lawton. Currently, all businesses pay municipal taxes but not all of them have their garbage picked up at the door by the town. The issue has been a contentious one recently and Mr. Lawton wants Halton Hills to change its "antiquated" methods of garbage collection to accommodate

businesses. A new system of garbage collec-tion, which would include the businesses which are now paying for a private pickup service, would help clean up the community, said Mr.

Lawton. "An overall' package needs to be designed."


The united chamber also plans to approach the town about designing more explicit parking and sign bylaws, he said.

REASONS FOR DESIGNATION "Acton Town Hall"

The Hall was completed in 1883 and is a good example of the monumental style of the late 19th century public architecture. The architecturally significant features of the building include its monumental and symmetrical massing along the front and side elevations; its arched window openings, highlighted by decorative key end stones and moulded brick sides designed to resemble pilasters; its italiante style roof trim featuring wide eaves with heavy shaped wooden brackets; the arched and brick pilaster trimmed front doorway and its wooden, detailed belfry tower.

The historical interest of the property lies chiefly in the fact that it was the tocal centre of the Town of Acton until Regional Government, as it acted as the community centre for virtually all Town of Acton related functions and services.

Any person may, within thirty (30) days of the first publication of this notice, send by registered mail or deliver to the Clerk of the Town of Halton Hills a notice of his or her objection to the proposed designation together with the reason for the objection and all relevant facts.

If such a notice is received, the Council for the Town of Halton Hills shall refer the matter to the Conservation Review Board for a hearing.
