#### Gas pedal sticks

Police say a malfunctioning gas pedal caused severe damage to a four-week-old car driven by a Georgetown man Friday night. The man was driving his 1989 Chevrolet to the car dealership when the gas pedal apparently stuck and the car reversed, striking a hydro pole on a local crescent. Police say there were no injuries and they will not lay charges in the single-car collision.

### Severe damage

A 1987 Ford was severely damaged after it struck a van parked near Edith Street in Georgetown Saturday morning. Police say the Ford was southbound when it went out of control and struck a parked 1988 GMC van, causing light damage to the vehicle. No charges were laid and police report no injuries.

#### 2-car collision

A two-car collision at King Street and McNabb Street in Georgetown resulted in damage to the vehicles Thursday morning. Police say a 1977 Oldsmobile went out of control while westbound on the icy road and struck a 1985 Subaru parked at the roadside. The Oldsmobile, driven by a Georgetown man, 43, was lightly damaged. The 1985 Subaru, driven by a Georgetown woman, 43, was moderately damaged. There were no injuries and police are not laying charges.

## No injuries

A Steeles Avenue collision caused extensive damage to a Ford Mustang Thursday night. Police say the 1981 Mustang was eastbound on Steeles Avenue near 10th Line when it struck an icy patch and slid into the path of a 1985 Pontiac. The Pontiac received light damage, while the Ford was severely damaged. Police report no injuries in the accident and no charges laid.

# Homebuyers left wondering

More than 20 people who have purchased houses on the west side of Mountainview Road in Halton Hills Village may lose them because their lots cannot be servic-

Bruce Hayward, a Georgetown resident who has recently sold his home and purchased a house from Fernbrook Homes on the west side of Mountainview Road, appeared before council Monday to ask for their help.

"They (Fernbrook Homes) were selling homes in areas which haven't been approved for homes," said Mr. Hayward.

Many of the people who have bought the homes live in Georgetown, he added.

What has happened, according to town deputy planner Bruce MacLean, is this:

Fernbrook Homes purchased 237 lots on the west side of Mountainview Road from the developer, Halton Hills Village Homes. Fernbrook began selling homes in the summer. In the late fall, Halton Hills Village Homes changed the phasing of the lots for the second time. Because of servicing limita-

tions, the firm is allowed a total of 510 homes. The re-phasing in the fall switched most of the homes to the road to the east side.
