STOCK SAVINGS PLAN

QUESTION: I started a Quebec Stock Savings Plan (QSSP) a year and a half ago. I expect that the market value of some of the shares included in the plan will fall in the next few months. If I withdraw those shares from my QSSP, must I add their value to my income for the year?

ANSWER: Yes, unless you add new shares of at least equal value to your QSSP before the end of the year. If the value of the shares is replaced in this fashion, you will not have an amount to add to your income. Further, if the selling price, less costs, of the withdrawn shares is greater than their original purchase price, the capital gain may be absorbed by your capital gains exemption.
