Deputy Chief John Barratt said he has been contacted by Frank Crann, the director of development review at Halton Region. He would not say what they talked about but he did say he had given Mr. Crann advice about a matter concerning the land division committee.

Mr. Crann acknowledged hearing rumors about a police investigation into committee dealings, but he said there is no confirmation of such an investigation going on right now.

"beautification project" but the stabilization would only bring the value of the homes back to their appropriate level, said Mr. Abray.

He said the town has a moral and possibly legal obligation to pay the repair bill.

"It is our understanding that... councils and their engineering departments are charged with the responsibility for the protection of homeowners from negligent developers and builders," Mr. Abray said. "Obviously the council that was in place over 20 years ago dld not provide the public with the protection which they deserved."

Although Mr. Abray said he wants the town to pay the entire 45per-cent share of the repairs, Mr. Stinson said some homeowners are willing to negotiate a cost-sharing formula.

But he wants to know the town's current position. "We want the town to tell us what your position is going to be and why."

Mr. Stinson also wants town staff to help homeowners find the records of 20 years ago to determine if the former town of Georgetown acted properly.

The decision on Metcalfe Court is important because whatever the town decides will likely be used as the formula for the 18 homes on the other streets, said Mayor Russ Miller.

And the project could cost Halton Hills taxpayers almost \$500,000, said Coun. Norm Elliott.

"The impact that will have on the budget is staggering. It's a \$1 million project."

Councillors will meet with homeowners on Monday to discuss the project and a final decision will be made at Tuesday's council meeting.

Halton's Chief Administrative Officer John Fleming said he has prepared a confidential report on the land division committee which will be presented to Regional councillors today (Wednesday). Councillors will then decide if the report should be made public.

Land division committee chairman Brian Fletcher has previously asked councillors to make the report public.

The land division committee has come under intense scrutiny at Halton Region since planning commissioner Rash Mohammed said about 13 per cent of the committee's decisions in an 18-month period do not comply with the Region's official plan. Critics of the committee say it is allowing too many rural severances resulting in fragmented farmland.

Committee members resign

Two long time members of Halton's land division committee have resigned.


Stan Procter of Oakville and Stella Parton of Milton say they no longer want to sit on the committee.

Gord wishes to thank all who took part, and assisted to make the day a success.




