# Halton not looking for "father-child" treatment

Halton wants to stop being treated like a child when it comes to operating a hazardous waste depot in Milton.

The Milton Household Hazardous Waste depot, which disposes of household wastes like bleach, paints and solvents, was closed in April following a Ministry of Environment notice of violation.

The Region responded to the letter, saying the ministry could have approached the Region personally instead of listing problems in a letter. If Regional staff had not closed the Steeles Avenue depot, some members could have been subject to fines or imprisonment, said Lyle Parsons, Planning Co-ordinator tor the Halton-Peel division of the MOE.

"We're looking for a partnership here, we're not looking for fatherchild treatment," said Burlington Coun. Rob Forbes last week. The Region "should not be treated as if we were doing something we were required to do."

Halton Region operates the hazardous waste depot without a direct order from the provincial government.

While there have been cries of injustice in Regional council this past week, some councillors say the MOE is not to blame for the depot closure.

"I think we've had enough of MOE bashing," said Coun. McLaughlin. The Region admits some of the guidelines agreed upon by the ministry and the Region "fell by the wayside," he said.

And Oakville Coun. Peter Arch says the Region should disband "an adversarial approach" with the MOE. "The onus is on us," he said to properly operate the facili-

Some councillors such as Burl-

ington Coun. Fred Oliver say the hazardous waste depot should remain closed because "we don't need this aggrevation," but most councillors want the depot doors re-opened as soon as possible.

"We want to get our problems ironed out so we can get this facility operating." said Coun. McLaughlin.

Halton Hills Coun. Joe Hewitt said the hazardous waste site is an option to storing and disposing of waste that could "find its way back into green garbage bags."

The Milton hazardous waste site could be re-opened in three to four months if storage and fire hazard problems indicated by the ministry are corrected.

"We deserve an 'A' for leadership and a 'D' for execution," said Burlington Coun. James Grieves.

## Seniors lose battle for nearby mail box

Trafalgar Road seniors lost their battle to stop Halton Hills from closing a laneway that gave them easier access to a post box.

The group, led by Bill Edie who lives on a property adjacent to the North Halton Golf and Country Club, appeared at town council two weeks ago to say a laneway owned by the town was a quick access for seniors to a Canada Post mail box. Without the laneway, they would walk twice as far. But town council voted to close the laneway joining Stewarttown Road and Trafalgar Road. "Since we are all ancients here, we don't need to have this done to us." said Mr. Edie to coun-

cillors Monday night,
Residents living near the laneway say the road is not safe for travel. "The actual road bed is no wider than a single driveway. It is not well-lighted (and) it is unmarked and not maintained," six local residents wrote to the town.

The residents, including the Gilletts, MacGregors and the Arsenaults said they hope town council will push for closer post boxes for the seniors who now travel to a box outside the Georgetown Little Theatre.

Mayor Miller said that although the laneway would be closed, the town would pursue communication with Canada Post.
