School board heads for 21st century

to work together Mr. Williams speculates schools will be significantly different 10 years from now. Schools will become professional learning centres for students and teachers, the net result being much more interaction between staff as to how and what should be taught, he said.

Mr. Williams said research shows people learn better through consensus rather than decree.

Staffing is Mr. Williams' other top priority. He said the board will need to hire 2,000 teachers over the next 10 years because of retirement and increased enrolment.

It is therefore the board's job to attract the top of the teaching field, he said.

Both Georgetown District High School and Acton High School principals agree Mr. Williams' initiatives are a step in the right direction.

Barb Singleton of Georgetown high school said the proposed strategy allows for greater flexibility in terms of making good use of the people in the system.

She explained in the future the school system will be confronted with more change than has been the case in the past, making a flexible system essential. She also liked the report's instructional focus saying education comes down to the relationship between teacher and student.

Acton's principal Karel Sury was pleased the report stressed the uniqueness of individual schools. He said communities' particular educational needs can only be met if the school is allowed the freedom to act independently.

But the two principals contained their enthusiasm saying several specifics had to be first worked out if the report is to be successfully implemented.

Halton Hills trustee Arlene Bruce was enthusiastic of the report saying it was a "bold move."

However, Halton Hills other board trustee Dick Howitt wasn't fully supportive of it. He said he disagreed with proposed changes

to the existing support staff structure.

If the proposal is eventually accepted, the number of field superintendents would decrease from five to three. The two would move to head office, Mr. Howitt said.

should live on. The Highland Games cost about \$45,000 to produce each year, with prizes going to winning bands and soloists, but costs are offset by contributions from local companies, national companies and even one liquor company in Scotland.

Last year the Games lost money, but this year Mr. Spicer predicts the event will pay for itself.

Communications were faltering between the Town of Halton Hills and the Highland Games organizers weeks before the annual scheduled event.

Mayor Russ Miller met with the game's organizers and said everything was fine. But Mr. Spicer said the town wanted to charge \$10 for each camping spot. This would mean the town would make a profit from the non-profit organization, he said.

But Coun. Joe Hewitt, Acton Mayor while Mr. Miller is out of town, said he heard people say at the Games Saturday, "why is the mayor letting us down?"

"There was no mention of the fact that the mayor was encouraging the Highland Games in Georgetown," said town administrator-clerk Dan Costea, who also attended the Games.

Coun. Elliott said there should be "open communication" between the Games' organizers and the town. He said that although the complaints about the town's apparent lack of interest in the Highland Games this year may not be legitimate "there's still a perception out there."
