"I think you're opening one heck of a can of worms," she said. "I think the presentation should be made when you've got the information," on whether taxes would increase or decrease in Oakville.

The Oakville mayor said she wanted "representative equity" not just "economic equity." The elderly in Oakville who are living in older homes would be heavilyimpacted by Region-wide taxation, she said.

Milton Councillor Brad Clements said he approves the new taxation scheme because Milton paid a 10per-cent tax increase last year while the Regional increase was only seven per cent.

"How can you explain that to a taxpayer. I think that's impossible," he said. "Therein lies another reason why I want to see this type of (study) go ahead."

Halton Hills town treasurer Ray King attended the two-hour tax session at Wednesday's finance committee meeting, along with several other Halton municipal treasurers.

But Mr. King said until figures are in from the Ministry study which will be completed jointly with municipal treasurers - he can-

warned that if the tax impact study was not approved soon, Halton could be "on the back burner" for five or six years, waiting for a study.

Finance Minister Joe Rinaldo

Regional Chairman Peter Pomeroy said provincial funding for the tax impact study could be cut off to municipalities in the next 18 months. The cost would shift to the local tax base, he said.

"That message was very clear during some discussions between the province and myself some time

Mr. Pomeroý persuaded Regional councillors to approve the tax impact study for more "equitable" system.

"Taxation isn't fair, no matter how you slice it, (but) this is a fairer system than the one that was in place before."

Police lay two drug-related charges

Two drug-related charges were laid over the weekend, one of which occurred after an incident at the Acton Fall Fair, Friday night.

The man is scheduled to appear in court Oct. 23 in connection with the charge.

Halton police investigate two fires

Halton Regional Police, the Burlington Fire Department and the Fire Marshall's Office are appealing for the puulic's assistance to solve two separate arsons that destroyed five newly constructed homes valued at approximately \$1 million.

The first fire was discovered at 2:48 a.m. on Sept. 2. This fire involved a single family home located on Lot 9, Lantern Lane, Burlington. The home was near completion, with an estimated property value of \$310,000.

The second fire took place on Sept. 4 at 1:06 a.m. Four residential homes under construction on the north end of Deerhurst Drive were completely destroyed. Estimated property damage for these homes has been given as \$670,000.


