

Police Beat

Window smashed

Halton Regional Police say someone smashed the driver's door window of a 1986 Pontiac parked outside a Mountainview Road residence in Georgetown causing \$180 damage early Saturday morning.

Theft charges

A 55-year-old Toronto woman allegedly stole a \$60 eel-skin purse from the Olde Hide House in Acton Sunday afternoon, police say. Charges of theft have been laid in connection with the incident. An Oct. 23 court date has been scheduled.

Egg thrown

Someone threw an egg at a 1987 Pontiac parked in a Duncan Drive driveway in Georgetown and hit the vehicle's roof, causing some paint to peel sometime during the past weekend. Police estimate damage to be \$100.

Impaired charges

Careless charges

The man went to Georgetown and District Memorial Hospital where he was treated with minor injuries. Police took away the man's driver's license.

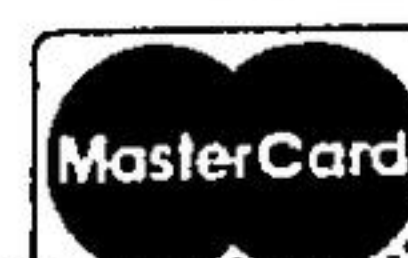
