

## Assault charges

Halton Regional Police laid charges of assault and robbery following two incidents involving a Georgetown youth Sunday.

In the first incident, a 15-yearold girl allegedly pushed and slapped the face of another girl, also 15, as she was entering a Mountainview Road Bowling alley in Georgetown Sunday afternoon. Later that night at Club 2000 in Norval the same 15year-old allegedly stole a gold ring and gold charm worth a total value of \$800 from the girl, police say she had assaulted earlier in the day.

## Windows broken

Police say a 29-year-old Erin man punched and broke two glass windows causing \$50 damage to a Guelph Street tavern in Georgetown after being asked to leave the premises for rowdy behavior early Friday morning. Charges of mischief were laid following the incident and a Nov. 20 court date was scheduled.

#### Narcotics charges

Police laid charges of possession of narcotics after pulling over a vehicle for a traffic violation on Duncan Drive early Sunday morning, when police pulled over the vehicle, driven by a 19year-old Georgetown man, they saw what appeared to be a marijuana cigarette in the ashtray. After searching the car police found 10.5 grams of a substance that is suspected to be hashish.

#### Minor injuries

A 19-year-old Georgetown man was taken by ambulance to Georgetown and District Memorial Hospital and treated for minor injuries following a traffic 'accident on John Street in Georgetown, Sunday evening. Police say the man was riding a bicycle eastbound when he attempted to stop for a 1983 Datsun, driven by a 49-year-old Georgetown woman, that was pulling out of a driveway. The bicycle went out of control and the man landed in a ditch. Charges of improper bicycle lighting were laid following the incident.

#### Two-car collision

Police laid charges of not giving the right of way following a two-car collision on Mountainview Road South of Guelph Street in Georgetown last Thursday evening. Police say a 1985 Impala

driven southbound by a 65-yearold Georgetown man without its headlights on collided with a 1985 Honda that was backing out of a driveway. An 18-year-old Glen Williams man was driving the Honda. .

#### Charges laid

Police laid charges of going through a red light following a two-car collision on Trafalgar Road at Steeles Avenue in Georgetown, early Friday morning. Police say a 20-year-old Georgetown man travelling northbound in a 1988 GMC failed to stop for a red light and collided with a 1987 Plymouth travelling westbound. A 57-year-old Georgetown man was driving the Plymouth.

#### Two-car accident

Charges of following too closely were laid following a two-car collision on Mountainview Road South at Delrex Boulevard in Georgetown, Friday morning, Police say a 1986 Toyota driven southbound by a 29-year-old Etobicoke man collided with the rear end of a 1985 Buick. The Buick was stopped at a stop sign at the time of the accident.

#### Two treated

A 27-year-old Georgetown man and a 27-year-old Toronto woman were taken by ambulance to Georgetown and District Memorial Hospital and treated for minor injuries following a two-car collision on the Ninth Line and Sideroad 10 in Georgetown last Thursday afternoon. Police say the woman was driving a 1983 Toyota when the vehicle collided with a 1988 Ford that was stopped at the intersection. The Georgjetown man was driving the Ford. The Toyota was severely damaged, police say. Charges of failing to stop were laid following the accident.

# Girl beaten with a tire iron

Halton Regional Police charged a 16-year-old Milton youth with attempted murder after a 13year-old Bramalea girl was nearly beaten to death with a tire iron Saturday after she was picked up in Norval, Saturday night.

The girls received blows to her head and body. She is currently being treated for compound fractures to the skull, multiple lacerations to the head, bruises and abrasions to the back and a compound fracture to the right hand.

Police say the girl was with a friend in Norval when they met three youths. The Brama'ea girl

left with the three and they drove to Milton. Two of the youths got out of the car at that time. Police say a youth told the girl he would take her to a "bush party" in the area of Appleby Line south of Derry Road in Burlington. When they arrived at this location, the two walked through a corn field and into a wooded area where the beating took place. The attacker then left the scene, police say.

The girl staggered to the road and flagged down a car whose driver took her to Milton District Hospital, where she received initial treatment.

## Police fire shot

On Oct. 11, 1989 at approximately 0255 hours an officer of the Halton Regional Police Force observed a suspicious vehicle eastbound on New Street in Burlington. The officer checked the licence plate and found that the vehicle had been stolen from Toronto.

The suspect vehicle was occupied by two non-white males and one white male in their late teens or early twenties.

The vehicle and occupants sped away from the officer on to the Queen Elizabeth Way and then on to the 403 cutoff. The vehicle left the roadway in Peel Region and the suspects fled on foot into a wooded area.

A member of the Halton Regional Police fired a shot at the suspect vehicle.

The suspects are still at large.

The incident is being investigated by Detective Sergeant Ted Waller, Professional Standards Bureau and Detective J.A. Chapman, Major Crime Bureau.


