

Glen town hall board elects executive Nov. 16

Another year is ending for the present Glen Williams Town Hall Board and our annual general meeting will be held Nov. 16 to elect a new board.

During the past year we have, with the aid of the 'rink rats' and donations from Halton Hills' Recreation Department, maintained the ice rink in the ball park for as long as weather permitted. Spring is celebrated by our annual shrub sale with the generous help of Sheridan Nurseries. This year we were pleased to offer a small token of our great appreciation by donating a Sheridan Nurseries sign on the Glen Williams town list across from Preston's store at Main and Confederation.

As a charitable organization, the town hall was able to assist in supporting the 'play group' and we were especially pleased that the community was able to acquire long needed playground equipment for the ball park.

As usual, we supported Canada Day, and this year it was held in the ball park with an emphasis on a family environment. This event, which was a great success, is only due to the efforts of a small group of people from the community who physically give their time for six months leading up to the event.

From time to time we have organized various activities for the community, however our most popular continues to be the children's Christmas party with free of charge presents and entertainment for Glen residents' children.

The hall is rented by many groups often and for company or private parties. The revenue from these events maintains the town hall and contributes financial to our schedule of events.

Many projects remain for Glen residents. A parkette on the north-west corner of Main and Confederation Streets has been under negotiation and development for over two years. Time has been spent in negotiations with the town and after a September council meeting it appears that a "village garden" will finally come to fruition in 1990. The corner plot will be turned into a place for all residents and guests to enjoy. Many people from the Halton Recreation Department, Sheridan Nurseries,

local gardeners and Glen residents are poised to complete this project now that agreement has been reached with the Town of Halton Hills.

These events and projects can not and will not continue without community support and involvement. We urge all Glen residents to join us for our annual general meeting at 7:30 p.m. on Nov. 16 at the Glen Williams Town Hall. Joe Hewitt, our Regional councillor, will be speaking about local water and sewage issues which is of critical importance to all area residents both on private wells and those already on town water.

Halton Regional councillors made little comment about Halton Hills' objections to the GTA, created earlier this year to study the waste management in the Metro Toronto area.

Regional councillors last week were given a copy of the proclamation made by local group POWER - Protect Our Water and Environmental Resources - that asked the town to object to the Greater Toronto Area committee on waste management. POWER's proclamation says the GTA is "undemocratic" and "unaccountable" to the public.

Halton Region is one of five regions in Metro that have

representatives at the GTA. Regional councillors voted earlier this year to be involved in the GTA process.

Discussion about the proclamation against the GTA focused on the intent of the document.

"Am I to believe that Halton Hills council says the GTA is undemocratic and unaccountable?" Oakville Coun. Fred Oliver asked the Regional planning and public works committee last week.

Halton Hills Coun. Marilyn Serjeantson, who had voted in favor of POWER's proclamation at a recent Halton Hills council meeting, said it is the town's intent to say

the GTA is undemocratic and unaccountable to the people.

Acton and Regional Coun. Rick Bonnette told the Regional committee that the POWER proclamation was accepted by Halton Hills town councillors following a "lengthy debate" and a 7-6 vote.

"It wasn't any majority vote," Coun. Bonnette said. He added that all Acton councillors had voted against POWER's objections to the GTA.

Milton Coun. Bill Johnson asked which councillors voted in favor of the GTA and if there was a recorded vote. Coun. Bonnette said there was no recorded vote but results were printed in local newspapers.

NOTICE OF PASSAGE OF A BY-LAW

TAKE NOTICE the Council for the Corporation of the Town of Halton Hills has enacted By-law No. 89-163 to designate "Goodlet's" at 86 Main Street South, Halton Hills (Georgetown) on property described as Part of Lots 3 and 4, on the corner of Main and Mill Streets in Young and Barber's survey, registered as Plan No. 27 in the Town of Halton Hills in the Regional Municipality of Halton, as being of architectural and historical interest under Part IV of The Ontario Heritage Act.

REASONS FOR DESIGNATION

Build by Dougal Reid in 1879 as a hardware store, the building is one of the oldest structures on Main Street. Only the McGibbon Block to the north on Main Street is known to pre-date it. Architecturally, the building is unique to Georgetown in that the entire facade is limestone with cut limestone rock-faced quoins on each side. The windows in the second and third floors are two over two double hung with semi-elliptical heads. The metal window hoods and brackets and the metal entablature and brackets distinguish the Main Street South face. The coursed rubble stone south elevation gives character to the alley, linking Main Street South to the rear parking area.

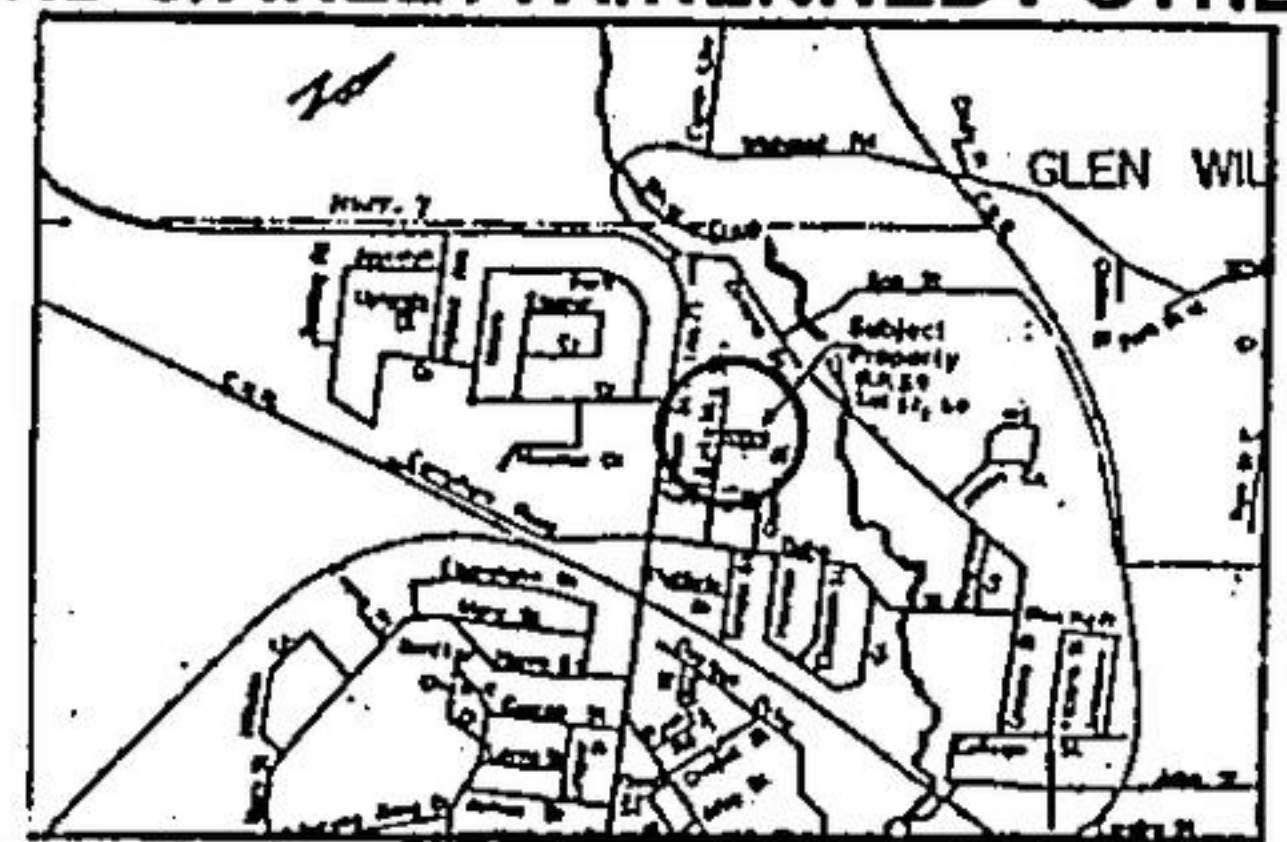

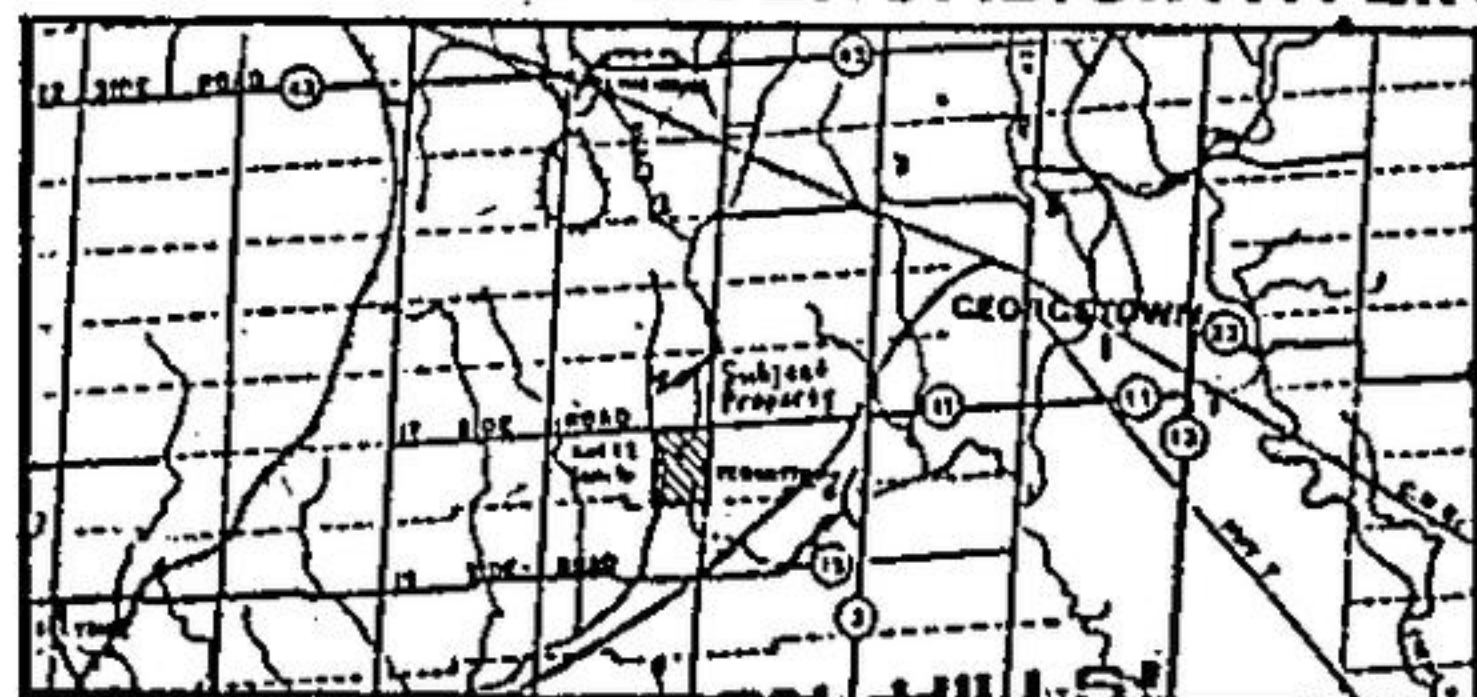

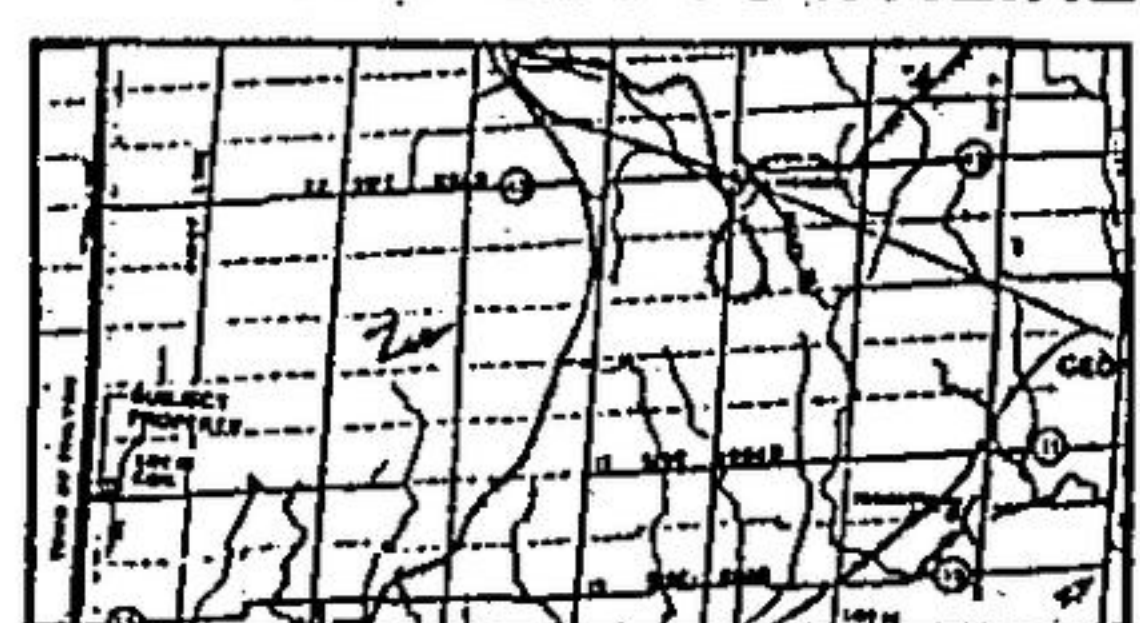
