"Do it yourself abortions" program offensive - reader

EDITOR'S NOTE: The following letter to Canadian Radio and Television Commission President Patrick Watson was filed with the Herald for publication. Dear Mr. Watson,

I wish to lodge a vehement complaint with regard to last evening's (Oct. 24) radio interview with a California woman on a segment entitled "Do It Yourself Abortions" aired on CBL 740 just before 7 p.m. on the program "As It Happens."

It was distasteful, offensive, unethical, dangerous and totally out of order to air that program nationally, locally - or at all. It was a blatant advertisement for a 20minute video made by proabortionists in response to the increasing number of U.S. states voting pro-life.

However, the detailed questioning by Michael Enright and the gratuitous responses on 'our own CBC' program left nothing to the imagination of the listener: Anyone can perform her own abortion, or her friend's. To quote the interviewee: "It's easy!" Is that responsible broadcasting? Detailed instructions on how to commit a murder, what easily obtained weapons to use and a visual

Keep the Environmental Assessment Act. Please no more efforts like Project X to get rid of Environmental Assessment.


