Charges laid

Scotsdale may be on short list

ed Scott's Falls, in Mono Township. This 400-acré site is "very similar" to the Scotsdale property, Mr. Creelman said.

Scotsdale is also owned by the provincial government and is managed by the Credit Valley Conservation Authority. The land was bequeathed to the town six years ago owners Lotta and Stewart Ben-

Mr. Creelman said in his conversations with the TSO, he has heard favorable response to Scotsdale's application.

'I know that Scotsdale has always been high on their list to start with," he said. Mr. Creelman said the sites at Kleinburg, Mono and Halton Hills "would be my shortlist ... if I had to guess."

In Halton Hills, local residents led by Carol Hewitt, formed a group to show their support for the TSO coming to Scotsdale. The group lobbied the Town of Halton Hills, which sent a letter of support to the TSO.

Those in favor of bringing the TSO to Scotsdale are taking a lowkey approach to promoting the farm as a choice for the orchestra's summer home. Petititons have been circulated and informal meetings were held in support of the summer home. plan.

Mr. Creelman said although he understands how quickly opposition can form to a major project like the TSO summer home, he is "surprised" at Halton Hills' approach.

"My feeling is it's better to have it out in the open and address all the concerns.

"We've really been out in the open about this thing here," Mr. Creelman said of the site located at Mono Centre Road. "As a consequence, we've seen some opposi-

The Kleinburg site located in the Town of Vaughan was one of the last sites to reach the TSO's list. Metro Toronto and Region Conservation Authority manager Ian Deslauriers said Friday the MTRCA recently asked the TSO to put a 2,000-acre site north of Woodbridge and south of Kleinburg on the list of summer home applicants.

The site would be split into parcels if approved for a TSO summer home.

The provincially-owned Boyd Conservation Area boasts of a natural amphitheatre, Mr. Deslauriers said.

"We made the suggestion to the Toronto Symphony Orchestra (to look at the Boyd site) after seeing an article in the newspaper," he said. "They haven't indicated whether they're interested in doing detailed investigation of this site." Mr. Deslauriers referred to the upcoming consultant's study.

But the sites at Scotsdale, Kleinburg and Mono still have no official approval for a TSO shortlist.

"We don't want communities getting their hopes up and thinking they .. . - forflist," Mrs. Hart said last week.

But Mr. Creelman said TSO officials have told him that community reaction to the TSO summer home will play a role in which community is chosen.

He said the orchestra "wants to see some expression of enthusiasm." Mrs. Hart of the TSO said the orchestra is looking for "community support" both in terms of willing employees and the urban centre to support the TSO as a business.

The land where the TSO summer home will be located must remain rural in character, Mr. Creelman

"If a summer home is located in an area that is protected, you can be pretty certain you're not going to get a string of fast-food locations or subdivisions," he said. Scott's Falls in Mono is sur-

rounded by provincially-owned land. Scotsdale Farm in Halton Hills is located near the hamlet of Ballinafad which is largely rural in character. The Kleinburg site could be affected by development in the Islington West area, Mr. Deslauriers said. But it is surrounded on three sides by provincially-owned land.

Attempted murder suspect stands trial Dec. 29

A provincial court judge ordered a 30-year-old Georgetown man to undergo psychiatric assessment before standing trial for attempted murder Dec. 29.


Kevin Blackmore is currently being examined at the Clarke Institute of Psychiatry in Toronto.

Toronto Metropolitan Police laid charges of attempted murder after a Toronto woman was stabbed several times at her Queen's Quay apartment in Toronto during the early morning of Oct. 23. Susan Bassett ' underwent emergency surgery for a punctured liver and multiple stab wounds at the Toronto General Hospital. She has since been released from hospital.

Police say the woman was stabbed a half hour after watching videos with the Georgetown man.

The two met earlier in the evening at a church meeting and returned to her apartment. The Georgetown man left the apartment at 12:30 a.m. and then returned a half hour later asking to use the phone.

Police say a man then chased the woman into the bedroom and "stabbed her about the body." The woman escaped and ran down the hallway banging on neighbors' doors yelling for help. The police were called and a man was apprehended while leaving the apartment.
