# Heaton wants federal help for waste crisis

Halton Hills Councillor Rob Heaton Saturday asked the federal government to help solve the garbage crisis in this town.

Coun. Heaton asked Halton-Peel MP Garth Turner and minister of state for small business and tourism Tom Hockin what the federal government will do to stop the Acton quarry from being used as a landfill site.

The two federal representatives of cabinet held an information forum Saturday at Acton's Trinity United Church.

Mr. Heaton commented on the application by local consortium Reclamation Systems Inc. to use the Acton quarry near Limehouse as a landfill site. That application is under provincial review.

"We're spending our money on tourism, yet we're being stymied" with nowhere to put increased gar-

bage from tourists, Coun. Heaton said.

But Mr. Turner said garbage is not a federal jurisdiction, although he agrees local groups should oppose landfilling at Acton.

"It would be a powerful detriment to tourists in this town. That's why we have to fight it to our last breath," he said.

General Committee for the Town of Halton Hills will conduct a PUBLIC MEETING to examine and discuss a proposal to rezone two blocks within an existing plan of subdivision from an open space zone to a residential zone to permit the development of these blocks for single family homes. The two blocks had been initially intended as part of a stormwater drainage management system. These blocks are now no longer necessary. as an alternative stormwater drainage system has been approved by the Town and therein these blocks may be considered for development pur-
