

## Police Beat

### Man killed

A 25-year-old man from Milton was struck and killed by a west-bound freight train in the area of Court Street, north of Main Street in Milton, on Jan. 4, Halton Regional Police say. They are still investigating the case.

### Break and enter

A culprit broke and entered the drug abuse centre on Guelph Street by removing a window, police say. The person appeared to know where the petty cash was kept but found none, police say. They also noted the culprit replaced the window when he left. The crime happened between 5:30 p.m. on Jan. 2 and 10 a.m. on Jan. 3.

### Narcotics charge

At 1:20 a.m. Jan. 8 a man was found unconscious on Main Street near Mill Street in Acton, police say. Police searched the man and found a large amount of substance which appeared to be hashish. A man has been charged with possession of an illegal substance and will appear in court on Feb. 12, police say.

### Door kicked

During the winter break the side door of a storage garage was kicked in at the Georgetown and District High School. It is unknown if anything was taken, police say.

### Tires slashed

Somebody slashed two passenger side tires of a vehicle parked on Main Street South in Georgetown, police say. The culprit struck overnight on Jan. 5 between 10 p.m. and 9:30 a.m.

### Man held

A 38-year-old Georgetown man was arrested for public intoxication on Jan. 6 on Mountainview Road. Police say he was transferred to 11 Division and placed in a cell overnight.

### Mail box damaged

A \$25 mail box was damaged overnight Jan. 6 in Acton between 5 p.m. and 9:30 a.m. Police say the complainant told them this has been occurring on a regular basis.

### Windows cut

Overnight Jan. 6 both of the rear plastic windows of a 1988 Suzuki were cut. The car was parked in an apartment lot on Main Street in Halton Hills, police say.

### Charge laid

A 53-year-old Woodbridge man faces a charge of failure to stop following an incident which occurred on Ninth Line and Sideroad 10 on Jan. 4 at 4:45 p.m., police say. A man driving a 1985 GMC van southbound on Ninth Line stopped at a stop sign and then proceeded through the intersection without seeing a 1983 Dodge travelling eastbound on Sideroad 10. The Dodge collided with the van, did a 360 degree spin, crashed through a fence, hit a utility pole and spun into a field. The driver and passenger of the Dodge received minor injuries. The Dodge was demolished and the van received moderate damage.

### Vehicles collide

A 30-year-old Georgetown man has been charged by Halton Regional Police with careless driving and not having insurance following an incident that occurred the afternoon of Jan. 6. A man driving a 1978 GMC started

to make a right-hand turn onto Steeles Avenue from Fifth Line, could not complete the turn and reversed into a 1979 Chevrolet. The GMC received light damage but the damage to the Chevrolet was severe.

### Vehicle rolled

An 18-year-old Milton man faces charges of driving under suspension and failing to produce ownership following an incident that occurred on Jan. 3. A man driving a 1983 GMC eastbound on Sideroad 10 hit a patch of ice sending his car out of control. The GMC slid across the oncoming traffic lane leaving the road and rolling over in a field. The GMC received moderate damage.

### Two-car collision

A 55-year-old Acton man has been charged with not giving the right of way. The charge follows an incident which occurred at a driveway on Main Street North Jan. 5. A man driving a 1973 Buick attempted to turn left onto Main Street from a private drive when it collided with a 1989 Ford that was attempting to turn left into the private drive from Main Street.

### Hood scratched

At noon on Jan. 7 someone scratched the hood of a 1989 Nissan causing \$250 damage. The car was parked on Church Street in Acton, police say.

### Three-car collision

Following a three-car accident Jan. 3 on Guelph Street, a charge of careless driving has been laid. A 1982 Oldsmobile collided with a 1987 Pontiac which in turn collided with a 1983 Honda. The Pontiac and Honda had stopped for traffic when the accident occurred. The Pontiac received moderate damage to its rear end while the other two cars suffered only light damage.

## \$6,000 damage to 30 cars

Property damage is a crime that affects everyone and in the Region of Halton 3,681 incidents of property damage were reported to the Halton Regional Police in 1988.

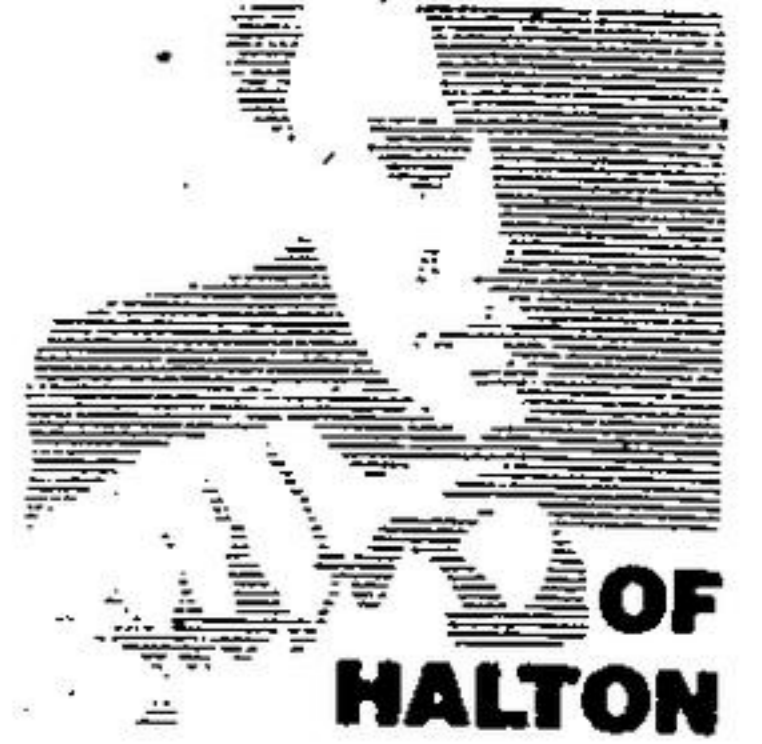
Crime Stoppers of Halton are looking for information to solve a rash of property damage occurrences involving 30 separate complaints totalling \$6,000 in damage and theft in the Georgetown area. The incidents under investigation took place overnight Friday, Dec. 10, 1989 between 3 a.m. and 5 a.m. Investigators believe youths who had possibly slipped out of their homes without their parents' knowledge, are responsible.

The streets of Mountainview, Bairstow Cres., Delrex Blvd., Prince Charles Dr. and Hawks Place were targeted by the two suspects. Windshield wipers were broken, gas caps opened, tires were slashed, paint scratched and vehicles entered, stealing numerous items such as a hockey bag containing men's hockey equipment and several cellular phones.

The following description of two suspects has been obtained from witnesses interviewed during the investigation:

Suspect No. 1: Male, white, 10-12 years old, wearing a bomber or ski jacket, dark grey

top with green V separating a light grey bottom, dark jean pants tucked inside calf high boots and grey hat. Suspect average height for a 12 year old.

Suspect No. 2: Male, white, 10-12 years, smaller than suspect No. 1. Mid length coat, blue jean pants, grey hat. Carrying unknown object.

## Man guilty of 'double doctoring'

A Toronto man has been found guilty on almost 40 counts of "doubling doctoring" in connection with illegally obtaining subscriptions from several locations in the Metropolitan Toronto area during the first few months of 1989.

Roberto Paul Rendace was also charged with 18 counts of double doctoring after obtaining prescription drugs from locations in the Halton Hills and Burlington areas during the same time period. But he wasn't found guilty on any of these charges, police say.

Mr. Rendace was recently sentenced to a year in prison and a year of probation in connection with the several counts of double doctoring occurring in the Metro area locations other than Halton

Region.

Halton police found Mr. Rendace with prescriptions for Florinal "C", a codeine that came from pharmacies, in areas including Halton Hills, Burlington, Newmarket and Mississauga. Halton Regional Police conducted their investigation during a two-week period last May.

In a double doctoring procedure someone receives prescriptions for narcotics to treat "bogus illness," police say.

Under the Narcotics Control Act anyone seeking prescriptions must inform the physician of any drugs prescribed during the previous 30 days.

Police credited the assistance of local pharmacists in helping them solve the case.
