Halton looks for someone who's helped environment

If you have a friend or neighbor that cares about the environment or has done a good deed for conservation, the Halton Conservation Authority would like to hear about it.

Many organizations and individuals care about conservation and have undertaken projects which enhance and protect the environment. In recognition of this, a conservation award program has been carried out by the Conservation Authority since 1982. The award was named after Ralph Sherwood, a long-standing and distinguished member of the Halton Authority, whose service and dedication to conservation extended over 20 years. The award is presented to a citizen or group who has made an outstanding contribution to conservation in the Halton watershed.

Last year, the award was expanded to three categories: individual, institutional and educational. In the individual category for 1988, Mr. Murray Harris was

selected for rehabilitating a significant portion of Limestone Creek located on his farm in north Burlington. As part of this project, Mr. Harris planted over 4,000 seedling trees, and fences were erected near the creek to protect the flood plain and the natural integrity of the watercourse.

In the institutional category, the Cumis Group Limited from Burlington was selected for their protection of an important local Carolinian Canada site. The Cumis Group owns approximately 100 acres of a 300 acre Carolinian Canada site called sassafras woods. The site is one of few representative examples of a southern exposure escarpment slope remaining in natural vegetation. The area supports a high diversity of provincially and regionally rare species, including sweet chestnut and sassafras tree.

invites written and oral responses from the community regarding the content of opening and closing exercises in schools.

On September 23, 1988, the Ontario Court of Appeal struck down the regulation requiring public schools to open or close with the reading of the Scriptures and the recitation of prayers. What was to be included in exercises, beyond the singing of O Canada, was left to the discretion of the board, though if readings were chosen they had to reflect the multi-cultural realities, traditions and values of Ontario society.
