Allan Burton, 24, of John Street, Georgetown, is in satisfactory condition in St. Michael's Hospital in Toronto, police say. Mr. Burton was driving this 1990 Plymouth when the car went out of control and rolled into a ditch on River Road just east of the bridge, at

approximately 1:15 a.m. Feb. 13. It took firemen just over 30 minutes to free Mr. Burton. The fire department had to enter through the rear window, pry open the passenger door and lift the car with air bags before they could safely move Mr. Burton.

#### Shots fired

Somebody shot at least 10 rounds of ammunition at an Ontario Provincial Police Communication Building located on Ninth Line south of Sideroad 10, Halton Regional Police say.

The shots were fired between Jan. 19 and Feb. 9 from a hunting rifle, police say.

One shot hit a diesel tank, spilling about 220 gallons of fuel into the earth.

Ten rounds of ammunition were found at the scene, police

say. In total \$700 damage was sustained by the building, police reported.

Someone broke into a Guelph Street television store in



# **1990 TAXES** INTERIM BILLING

In accordance with the provisions of The Municipal Act, pursuant to By-Law 90-2 adopted by Council on January 15th, 1990, the first two instalments of taxes for 1990 will become due as follows:

ALL WARDS - FIRST INSTALMENT - WED., FEB. 28th, 1990 - SECOND INSTALMENT - WED., APR. 25th, 1990

The above instalments represent an interim billing for 1990 taxes based upon an average of one-half of last year's residential mill rates. The final tax bill will be issued about the middle of the year and will also be payable in two instalments, normally the last Wednesday in June and September.

Upon default of payment of the interim levy as set out above, a penalty of one and one-quarter (11/4) percent of the amount in default shall be added on the first day of default and on the first day of each and every calendar month.

Ratepayers who have not received a tax bill should make immediate application at 1 Halton Hills Drive, Halton Hills (Georgetown) Ontario.

## Break and enter in Milton

Halton Regional Police in Milton are seeking the suspects responsible for two break, enter and thefts at the Derry Dispensary, 3006 Derry Rd. in Milton.

The entries took place early Saturday morning, Jan. 6, and again at 5:30 a.m., Tuesday, Jan. 16. In both instances entry was made by breaking a plate glass window. Once inside the culprits went straight to the dispensing counter and forced open the cupboards and drawers removing the drugs and narcotics. The cash register was also rifled with a quantity of cash being taken.

Although the alarm system was activated and the police responded within minutes, no suspects were observed in the area.

Drug stores can be a target for drug users who often steal for their own use as well as selling the stolen narcotics to others.

The stolen drugs included: Robitussinac, Phenegran VC, Tussaminic DH Forte, Dimetane, Dilaudid, Seconal, Lomotil, Novoridazine.

# Milton store robbed at knife point


