# Halton taxpayers could be facing a \$61.72 increase to their 1990 tax

bill if Regional council approves the recommended 1990 operating tax-supported budget during a vote today (Wednesday).

If Halton's proposed taxsupported budget, which calls for a 10.3 per cent increase, is approved, the average Halton household will pay almost \$660 for all Regional services this year.

budget.

But households in Halton Hills are not recognized by the Region as average. Georgetown and Acton residents will see their costs for Regional services increase by 12.5 per cent. The 1.8 per cent difference is due to a special levy for several Credit Valley Conservation Authority capital projects that only pertain to Halton Hills, and a formula determining assessment, said the Region's treasurer, Joe Rinaldo.

Regional services are expected to cost almost \$100 million, said Mr. Rinaldo. The tax-supported budget represents about 60 per

The Region's director for budgets, Dave Birkett, said staff was confined in its ability to control the budget. He explained that

# Taxpayers face 10.3% hike

The Regional tax bill is made up of three components: the taxsupported budget for Regional services (such as police, health and public works); water and sewage rates; and the solid waste disposal

The tax-supported budget calls for the average household to pay just over \$270 this year for Regional services - a \$26 or 10.7 per cent increase over 1989.

crease results from several provincial programs being offloaded on to the municipalities last year and in 1990. And since the inflation rate is about 6 per cent, Mr. Birkett said, "there wasn't much room for flexibility."

Provincially initiated programs introduced to the municipalities last year affecting the 1990 operating budget total just over \$1 million. Unemployment insurance and payments to the Ontario Health Insurance Plan represent the largest of this total adding \$470,000 to the budget.

New programs introduced this year by the province total just \$1.7 million. The largest expense is \$260,000 for court security.

But the Region did cut just over \$91,000 from the operating budget during the last two months. Most of the cuts were made in the area of administration.


Regional council has already approved increases to water and sewage rates of 4.3 and 7.3 per cent respectively over last year. The water rate will increase by \$6 from \$139 last year to \$145 in 1990. The sewage rate will increase by \$12 from \$168 to \$180.

Council has also approved a solid waste disposal budget that calls for a 38.6 per cent increase from \$44 in 1989 to \$61 this year. This expense is expected to decrease in 1992 when Halton is expected to open its Regional dump site in Milton.


