the time their meter is read. Currently people are sent their bill at the end of the month.

Neither Mr. Allison nor Mayor Miller would comment why Mr. Allison spent \$1,000 more than the mayor at the New Orleans convention.

The I.E.E.E. conference is held every two to three years, said Mr. Allison.

Mr. Allison sald commissioner Roger Haggett was the commissioner who questioned the commission policy on compensation. Mr. Haggett first made the enquiry shortly after being appointed to the commission in August in 1989, said Mr. Allison. Commissioners have since decided to introduce a resolution eliminating spousal support at conventions. It is expected to pass in April.

There is a lack of uniformity, said Mr. Smith, meaning some commissioners might spend less at conventions but they receive a large salary. Herein lies any possible confusion on the part of the public about the expenses of hydro commissioners, he said.

Mr. Smith would like to see an overall structure to create uniformity between comparably municipal utilities. A limit would be set on commissioners' salaries and how much they could spend at conferences in a given year, said Mr. Smith. Then there would be no basis for confusion, he said.
