

Youths charged

Halton Regional Police say three Georgetown youths and one Milton youth have been charged with possession of stolen property over \$1,000. Four youths were seen working on a motorcycle at a Guelph Street gas station April 16. One of the Georgetown youths has also been charged with mischief after a name was scraped into the paint of a cell bed at the Guelph Street police station in Georgetown at 4 p.m. April 16. The motorcycle is worth an estimated \$1,500 and the damage to the cell was approximately \$50.

Motorhome entered

A 1975 GMC Corsair motor home in Georgetown was broken into between April 12 and April 17. Two skylights were damaged and a door handle was broken as the thief took a 14-inch color television worth \$300, a fire extinguisher worth \$50, an old style video cassette recorder worth \$200, 50 assorted country and western cassette tapes worth \$200 and 25 assorted 8-track tapes worth \$100. Total value of the items taken is \$850. Police say the thief entered through one of the skylights.

Saw stolen

A 10-inch electric mitre saw with a 10-inch blade and a set of blades were stoken from a truck parked at an Erin Street residence in Glen Williams between 9 p.m. April 16 and 6 a.m. April 17. The items were sitting in the truck and were not secured, police say. The stolen items are worth approximately \$600.

Theft charge

A 16-year-old youth was arrested and charged with theft under \$1,000 and possession of stolen property, police say. A rear personalized license plate was removed from a 1982 Ford when it was parked in an Agnes Street parking lot April 12. The plate was put onto a 1979 Chevrolet and driven to Milton. The Chevrolet was stopped in Milton. The plate had been reported stolen earlier the same day.

Bus-car collision

A bus collided with a car as it pulled out of a Main Street North gas station at 1:50 p.m. April 7. The 1989 bus, driven by a 61-yearold Toronto man, was pulling out of the gas station when it collided with a 1981 Ford, driven by a 55year-old Georgetown man, that was headed south. The bus was making a right hand turn into the southbound lanes when the collision occurred. Police have laid a charge of not giving the right of way.

Assault charge

A 23-year-old Georgetown man faces a charge of assault after an incident that started at a Norval tavern April 15. The assault was originally reported to have taken place at the establishment but police say the assault actually occurred at a McIntyre Crescent residence. At about 1 a.m. a 32year-old Georgetown man was assaulted at the residence. The man will appear in front of a judge at the Milton Court May 14.

Charge laid.

A man has been charged with careless driving following an accident on Sideroad 10 east of Ninth Line at 11:20 p.m. April 12. A 1989 Chrysler, driven by a 45year-old Milton man, went out of control at a curve in the road. The Chrysler hit a ditch and turned over, police say. The driver was taken to Georgetown and District Memorial Hospital to be treated. for minor injuries. The Chrysler was demolished.

Two injuries

Two people were injured when a 1990 Yamaha motorcycle went out of control on Sideroad 15 near Fifth Line at 1:05 p.m. April 15. The Yamaha, driven by a 26year-old Brampton man, was going west when it hit some sand, went off the road, hit a bump and went out of control, police say. The driver and passenger were taken to Georgetown and District Memorial Hospital to be treated for minor injuries. The Yamaha received moderate damage.

Man charged

A man faces a charge of careless driving following an accident which happened on Sideroad 5 east of Fifth Line at 4 p.m. April 15. A 1988 Ford, driven by a 37-year-old Georgetown man, heading west, went off the road and continued for 50 metres before colliding with a fence post, police say. The Ford received moderate damage.

Death threat

A 16-year-old man was assaulted and threatened with death when he was looking for a friend's bicycle near the intersection of Young Street and Queen Street in Acton, Halton Regional Police say.

The victim was looking for the bicycle with another youth at 8:15 p.m. April 18 when the incident happened.

A golf club iron was used to prod the victim several times and finally to shove the victim's head against a window.

The attacker then threatened the victim with death.

A 16-year-old youth has been charged with assault with a weapon and threatening death, police say.

The youth will face the judge at the Milton courthouse May 3.





is a hold-up. I have a gun." A large quantity in assorted bills was passed to the suspect, who then walked from the bank and was last seen walking east from the bank.

The suspect is described as male, white, 40 years, 6'-6'2", large build, over 200 lbs., clean shaven with pencil thin, medium brown moustache over the upper lip. He was wearing thick glasses with dark brown rims, dark brown English style driving hat, full length beige-colored trencheoat with brass-colored buttons and dark leather shoes with laces.

The suspect was also wearing thick surgical type gloves.
