

Halton Hills council decided Monday to allow an area resident to convert a building formerly used for storage as a temporary second residence despite town staff recommendations opposing the

Councillors made the decision on compassionate grounds after John Gallo, the owner of the building, which is located on his apple orchard located at Lot 15 and Concession 6 in Esquesing, appeared before council and argued that without the residence he couldn't run his apple orchard.

Mr. Gallo explained the temporary residence is needed to house the seasonal workers he hires as apple pickers. Mr. Gallo said the workers are needed because a leg injury he sustained about a year ago in a car accident prevents him from picking the apples himself.

Until Monday the building wasn't zoned for housing. Mr. Gallo told councillors his leg is healing and should be completely healed in about a year and a half.

On this basis, council decided only to allow the temporary residence for a year-and-a-half instead of three years as Mr. Gallo had originally proposed.

Mr. Gallo said he required the residence to also house the workers during the off-season for general maintenance around the farm and to do the pruning of the trees.
