Ontario Municipal Board jackhammers plant

The Town of Halton Hills may have to reassess its official plan because of the Ontario Municipal Board's (OMB) recent decision denying Ontario Paving Company Limited the right to establish an asphalt plant at Steeles Avenue and Winston Churchill Boulevard. said Glen Wellings, a planner with the town.

"We'll have to look at the Official Plan because of the issues raised in the OMB decision," he said.

Mr. Wellings was referring to the temporary use bylaw that Halton Hills council had passed that initially gave the paving company approval to establish an asphalt plant for three years at Whaley's Corners, without first amending the town's Official Plan.

The site is designated rural, meaning under normal circumstances the Official Plan would have to be amended designating the area industrial.

But the town used a notwithstanding clause in the Official Plan to issue the temporary use permit and therefore avoid amending the Official Plan.

OMB Chairman Ted Yao ruled in his decision the town could only use the notwithstanding clause if all other aspects of the Official Plan were excluded. But Mr. Yao wrote, "it is clear it (the town) did not act as if the rest of the plan, for example, the policies on separation of industrial and residential areas, site plan control and holding bylaws

were to be ignored."

He also said "A development proposal should not escape all scrutiny simply because it is temporary."

Mr. Wellings said previous decisions made by the town using the notwithstanding clause will not be affected by the OMB decision because the related bylaws are now in place. He wouldn't comment further on the OMB decision saying the town's solicitor is reviewing the case.

But Mayor Russ Miller considers the asphalt plant a "dead issue."

Mayor Miller said of the decision, he's not really suprised. The residents too were not surprised at the outcome. "We (the resident group), vere confident we'd win," said association member, Marg Teggart.

"We are going to throw a party and we won't be inviting Mayor Miller or (the area's Regional representative) Joe Hewitt," said Ms. Taggart. Their shortsightedness on the issue of planning cost the group a lot of work and money, she said. The local councillor for the area, Robert Heaton, was the only town councillor who gave us support, said Ms. Teggart.


