Council briefs

Mayor wants signs restricted

Halton Hills Mayor Russ Miller directed town staff Montay to investigate the possibility of the town passing a bylaw to restrict where political party signs can be posted on public property. The mayor argued that the signs add to the environmental problem. As well, those posted near crosswalks pose a safety hazard to pedestrians, he said. They block people's view, argued the Mayor.

Councillor Pat McCarthy argued restricting the signs would give the incumbent politician an unfair advantage over those condidates who are not as well known in the community.

Parking problem

Acton Councillor Norm Elliot asked the town's Administrator Clerk Dan Costea, Monday, to request that Halton Regional Police step up its enforcement of the no parking area along the south side of Elizabeth Drive in Acton adjacent to the soccer pitch.

During soccer games the cars are lined up along the street blocking the movement of two-way traffic along the street, he said. The councillor also called the current situation "an accident waiting to happen." Children walking onto the street from between the parked cars cannot be seen and could easily be struck by an oncoming car, said Coun. Elliot.

Four-way stop



Should attend meeting


