existing trunk sewer in the Silver Creek was built in 1959.

The residents are opposed to the twinning of the trunk sewer because in passing through the Silver Creek Valley sensitive wetlands may be harmed, said Ms. King. According to Ms. King, the wetlands are classified as class two wetlands - class one being the most sensitive. As proof of possible damage she points to some of the wetlands that are already damaged by the existing trunk sewer.

Regional staff won't take a position on the proposal until after a public information meeting. scheduled for Oct. 23 at Halton Hills Civic Centre, is held, said Paul Maslovskis, a Regional Engineering Studies and Research Technologist.

Only after staff has considered the comments made during the information session as well as a con-

sultants report done by Marshal, Macklin, Monhaghan Limited which favors the twinning of Silver Creek Trunk Sewer, will staff a recommendation to make Regional council, he explained.

The report recommended Regional staff support the Silver Creek Trunk Sewer over several alternatives including a pumping station.

The report highlights the Silver Creek alternative, said Mr. Maslovskis, because it is "gravity fed." That means the sewer runs downwards and the velocity of the water automatically cleans the pipe, he explained. This greatly reduces the possibility of the sewer becoming blocked, said Mr. Maslovskis. As well, this alternative will have no negative environmental impact on the valley. he said. The consultant's report shows the disrupted area caused by the construction of the sewer

will return to its natural state over the long term, he explained.

Comparatively, the consultant's report shows a pumping station type sewer is less reliable, said Mr. Maslovskis. Since the pump is run on electricity, a power outage in the area would cause the sewer to shut down. In turn, the sewer could become blocked and the waste water could back up causing flooding to people's basements, he explained.

But Ms. King questions why isn't the Region considering back up emergency generators as is done at other similar regional projects.

During her meeting with regional staff, Ms. King said she was given similar arguments by staff to support the Silver Creek Trunk Sewer. Ms. King said the regional staff defended the Silver Creek option because it was the least expensive of the proposed alternatives.

Ms. King argues the Silver Creek optin isn't as inexpensive as regional staff proposes because it has yet to acount for the cost of building possible access routes to the sewer so that it can be servic-

Ms King goes on to argue, "too many projects have been proposed in the valley and no one is properly assessing the cumulative impacts. This includes the proposed new trunk sewer. Test Well 15, the Mountainview Road Landfill Bridge, a golf course and the widening of the Eighth Line.

The public information session runs from 6 p m. to 9 p.m.






