-Peoples Forum-Turner finds an ally

The Editor:

I've noticed recent letters to the editor criticizing Garth Turner M.P., and I felt that it would be appropriate to share my experiences.

My company, Purity Life Health Products, imports and distributes to health food stores, doctors and other health care practitioners coast to coast. We sell foods, body care, herbs, vitamins and ecological products which are organic, non-allergenic and speciality. As they are imported, most of which from the U.S., the labels are conforming with U.S. regulations, but not always Canadian regulations (lack of french, metric, different

nutrient declarations requirements).

Our problems started one year ago when Consumer and Corporate Affairs (CCA) decided to crack down on all imports coming into Canada not properly labelled, and suddenly we and our entire industry had problems.

We have always been able to get U.S. suppliers to do Canadian labels on large volume items, but in our industry there are lots of small volume items that would cost too much to relabel, yet if we were to lose them we would be out of business.

On behalf of Purity Life and our industry (The Canadian Health Food Association) I approached Garth Turner, who took the time

to understand our situation. Garth knew I have worked for the Liberals in the past, yet his support of us has been excellent. We do have a legitimate point of view and concern, and he has on our behalf met with the Minister of Consumer Affairs, Pierre Blais and arranged meetings between myself and members of our industry with senior people at CCA in Ottawa.

As a result of these meetings we are in a dialogue, there is an understanding of our situations, and we are expecting a solution that is win, win for everyone.

Garth Turner, in fact, most M.P.'s, regardless of their party work hard for their constituents, and are continually torn between the demands of various, often conflicting groups. Garth Turner listens, and makes it clear that he will only support situations that are reasonable and fair, and I respect him for it.

A guick word about the G.S.T. In spite of the flaws, it is vastly fairer than the present F.S.T. program which is so unfair that people would be far angrier at the way it is applied than the G.S.T. if they knew, but since its hidden they don't. Our problem as a country is that we insist on a full range of government programs and yet don't want to pay for them. Universal medicare is the worst example - a monster gone mad. People that need help should get it but universality is not necessary and promotes waste and inefficiency. So until we stop wanting "the government" to look after us, we can expect G.S.T. and more.

Garth Turner is one man who is trying to help, and I feel is effective at it. He could break with his party, which would mean he wouldn't be listened to, or he can work within it. By working within it, he is able to make his views known and have some influence. Garth is a man of principals and deserves our admiration and respect. He has mine.
