

### Theft at arena

Halton Regional Police say an Acton hockey player is missing \$400 after a hockey game in the Acton Arena on Dec. 30 between 7:30 and 8:00 p.m. The player told police unknown suspects entered locker room number two at the arena and removed \$400 he was carrying to pay his brother's mortgage. He, along with fellow teammates, believe the locker room was locked but weren't sure if the side door was.

### Chainsaw stolen

A yellow McCullough chainsaw was stolen from a garage on Cobblehill Road in Acton, police say. A resident of the home said the chainsaw was stolen from his garage between Dec. 7 and 30. Before he reported the theft, the resident attempted to locate the saw himself.

### RIDE blitz

Halton Region policemen were exceptionally busy during December when their annual RIDE blitz was held. This year, 26,695 vehicles were stopped with only 14 drivers being charged with impaired driving. These figures indicate only one impaired driver per 1,906 cars checked. Of the total number of vehicles stopped, 263 were given roadside alert tests from which 48 drivers got 12-hour suspensions. This makes one suspension per 556 cars checked. Other drivers were given warnings (609) and 87 people received other charges. Compared to 1989 statistics, the drinking and driving problem seems to be improving since one in 1,076 drivers were impaired last year and 1 in 430 drivers received 12-hour suspensions.

municipality pays towards an Authority's budget corresponds to the amount of area under the Authority's jurisdiction within the municipality's boundaries. For instance, the CVCA's area of jurisdiction falls in the municipalities of Halton, Peel, Township of Erin and Orangeville.

The remainder of an authority's budget is funded by the province, which under the act represents 55 per cent of ar authority's budget.

The province, however, only paid 46 per cent of the HRCA and CVCA 1990 budgets. That means the conservation authorities re quested Halton make up the shortfall, which the Region has refused to do. In the case of HRCA, the shortfall is \$141,000 while the Region owes the CVCA \$1,400.

According to Mr. Owen, legal action probably wouldn't happer until Regional Chairman Peter Pomeroy meets with the province in an attempt to resolve the disagreement over funding. "The CVCA doesn't relish the thought of going to court," said Mr. Owen.

Mr. Stephen said, however, there is no indication a meeting will be held.

The Region first told the authorities last month a January meeting with the province would be scheduled.

"The Region had to Dec. 31 to get a meeting with the province or reconsider their position," said Mr. Stephen. Horever saying there will be a meeting doesn't resolve the problem," he added.


Both Mr. Stephen and Mr. Owen said the added financial burden on the Region results province the from "downloading" programs to the Authorities without increasing funding.
