The purpose of the "Christ in the Passover' presentation is to enhance the Christian understanding of the New Testament by showing a Jewish background for the communion celebration. Ancient and modern Jewish customs are described with an emphasis on the aspect of the redemption accomplished by Christ at Calvary.

Dear Sir:

I wish to comment on an article in the Herald, dated February 20, 1991, entitled "Mainstream Christian clergy morally bankrupt." The writer of the article, Derek Nelson, referred to the Primate of the Anglican Church of Canada, Archbishop Michael Peers, as a morally bankrupt church leader. This accusation was directed at Archbishop Peers as a result of Nelson's disagreement with the Archbishop's position on the Gulf war. In a letter sent to all Anglican congregations in Canada, dated January 17, 1991, Archbishop Peers stated that the actions of Saddam Hussein were unacceptable and contemptible. The Archbishop, however, rejected war in the Gulf as it did not meet the test of morality.

In a violent age such as the one in which we live, it is imperative that church leaders question the continued use of violence to settle family disputes, political and religious conflicts. Furthermore, Canada is a democratic country. All citizens, including religious leaders, are entitled to express their opinions. One writer in the United States, Dorothee Soelle, has stated in her book "The Window of Vulnerability, A Political Spirtuality," that anyone who questions military action is "demonized by the religious Right, and called an aide to the communists." I would ask therefore, "Is the calling of the Primate morally bankrupt, a call for silencing dissent?"

Secondly, the Anglican Church of Canada has over forty clergy who are permanent chaplains to Canada's forces. The Anglican Bishop Ordinary to our forces is the Rt. Rev. J.C.M. Clarke. Members of the forces attend the councils of the church and participate in the debates on issues relating to defence, war and peace. These debates such as the appropriateness of military flights over the Innu people in Labrador are an indication of moral responsibility within the church community.

In conclusion, may I ad that we have five families in our congregation who have family members in the forces. We are grateful that the war is over. In our public worship, during the war, we prayed for the members of our forces, the Prime Minister and for all innocent civilians.

homes takes about four hours.

. Many of the elements of the Passover feast are observed by Orthodox Jews today in the same manner that they were in Jesus' time. However, the Passover meal no longer includes lamb. This omission symbolizes grief over the destruction of the Temple in Jerusalem in A.D. 70.

In contrast, many of the Jews for Jesus do eat roast lamb as they celebrate Passover in their homes. "We, too, grieve over the destruction of the Temple," comments Moishe Rosen, "but at the same time, we believe all the

Temple sacrifices pointed to Jesus, and the once-and-for-all sacrifice he made. We eat lamb as an affirmation of God's provision for us.

Jews for Jesus gives these presentations as an invitation for believers in Jesus to learn about the Jewish roots of their faith. Non-Christians are invited, as well to come and observe how Jews for Jesus see Christ in the Passover.


