Halton Regional Council will consider today (Wednesday) the approval of \$48,322 as its share of the Credit Valley Conservation Authority 1991 budget.

Although the Authority's 1991 budget has increased 8.2 per cent over last year to just over \$1.6 million, the amount Halton is required to contribute is lower than last year's amount, according to a Regional report by Halton's Treasurer, Joe Rinaldo.

Under the province's Conservation Authority Act, Halton is required to pay \$49,875 in 1991 down from \$57,295 the Region paid last year.

Mr. Rinaldo has recommended Regional council approve its contribution to the CVCA since Regional councillors alloted \$60,700 to the authority in its 1991 operating budget.

Councillors' costs total \$550,899.08 Halton Regional councillors

will learn today (Wednesday) that 1990 councillor salaries and expenses totalled \$550,899.08.

According to a Regional staff report that will be presented to council today \$485,632 was paid out in salaries to the 24 Regional councillors and Halton Regional Chairman Peter Pomeroy. Councillors, of which four are from Halton Hills - Mayor Russ Miller, Marilyn Serjeanston, Rick Bonnette and Joe Hewitt - were each paid \$17,463.

The chairman's 1990 salary was \$66,498.

The Region spent \$34,316 towards councillor benefits, \$132,885.76 for their car mileage and meeting allowance expenses, and \$17,063 for conference expenses, the report's author, Rinaldo Halton Treasurer Joe wrote.

Halton Regional Councillors Bonnette, Johnston and Mayor Miller spent \$1,314, \$1,691 and \$1,304 respectively on conferences last year. Coun. Bonnette and Mayor Miller both attended the five-day Federation of Canada Municipalities in Quebec conference this past summer, while Coun. Johnston attended the six-day Government Refuse Collection and Disposal Association Conference in Vancouver.

Coun. Serjeantson and Coun. Hewitt had no conference expenses last year.



TAX TALK

Q. I gave my son a Canada Savings Bond for his birthday. Now I'm told that I have to report the interest it eams on my tax return. Is this true?



A. Yes. You must report the income from any property you give a child under 18 with whom you're not dealing at arm's length. This prevents a taxpayer from artificially reducing his income by splitting his assetsamong different family members. However, any income arising from the investment of family allowance payments, so long as they are deposited in account in the child's name, will be considered income of the child's.


